ORDERS FOR PUBLIC PROCEEDINGS

KOSS SECURITIES CORPORATION, OTHERS

Administrative Proceedings under the Securities Exchange Act of 1934 have been ordered against Koss Securities Corporation of Brooklyn, New York and its president and director, Theodore Koss of Brooklyn, New York based on staff allegations that Koss Securities and Koss were convicted of the criminal charges of conspiring to violate the securities laws, mail fraud and securities fraud. It is also based on violation by Koss and Koss Securities of Regulation T promulgated by the Board of Governors of the Federal Reserve System. A hearing will be scheduled by further order to take evidence on the charges against the defendants. The Commission also ordered interlocutory administrative proceedings against the firm to determine whether, pending final determination of the issues alleged in the order for proceedings, it is necessary or appropriate in the public interest and for the protection of investors to suspend the broker-dealer registration of the firm. INVESTMENT COMPANY ACT RELEASES

GPM BALANCED FUND, INC.

A notice has been issued giving interested persons until September 23 to request a hearing on an application of GPM Balanced Fund, Inc. of Boston, Massachusetts, for an order exempting it from certain provisions of the Act to permit shares of the Fund to be sold without sales charges to persons who were shareholders as of November 16, 1972. HOLDING COMPANY ACT RELEASES

OHIO EDISON COMPANY

An order has been issued authorizing Ohio Edison Company (Ohio Edison), and its subsidiary, Pennsylvania Power Company (Pennsylvania), to enter into an agreement of sale with the Beaver County Industrial Development Authority (Authority) for Ohio Edison and Pennsylvania to construct pollution control and waste disposal equipment and facilities at the Beaver Valley Power Station to be financed by pollution control revenue bonds to be issued by the Authority. APPALACHIAN POWER COMPANY

An order has been issued authorizing Appalachian Power Company (Appalachian), subsidiary of American Electric Power Company, Inc., to increase the aggregate maximum amount of short-term indebtedness which can be incurred by Appalachian from \$100 million to \$150 million. (Rel. 35-18543)

MICHIGAN WISCONSIN PIPE LINE COMPANY

The SEC has authorized Michigan Wisconsir Pipe Line Company, pipeline subsidiary of American Natural Gas Company, to issue up to \$100 million of promissory notes to banks or, in lieu thereof, up to \$75 million of commercial paper to a commercial paper dealer. The proposed borrowings will be utilized to retire currently outstanding short-term borrowings, make advance gas supply payments and to finance, in part, the company's 1974 construction program (estimated to cost \$112 million).
