ADOPTION OF AMENDMENTS TO RULE 3b-3, RULE 10a-1 AND RULE 10a-2

LIBRARY

The SEC announced today the adoption of amendments to Rule 3b-3, Rule 10a-1 and 10a-2 under the Securities Exchange Act of 1934 modifying its existing short selling regulation in response to the contemplated implementation of a consolidated transaction reporting system declared effective under Rule 17a-15. The amendments prohibit any person from effecting a short sale of a security below the last sale thereof (a "minus tick") or at the last sale thereof if the preceding different sale was effected at a higher price (a "zero-minus tick") reported in such consolidated system. Short sales by any registered specialists, exchange market makers or qualified third market makers, registered or qualified in such a security, effected at prices equal to the last sale reported in the consolidated transaction reporting system would be exempt. Other minor exemptions are provided for. The amendments to Rule 3b-3, Rule 10a-1 and Rule 10a-2 become effective October 4, 1974 to coincide with the implementation of the "pilot phase" of the consolidated tape. It should be noted that the existing short sale tick test employed by Rule 10a-1 remains in effect for trades in all securities that are not reported pursuant to the consolidated tape plan. REQUIREMENTS FOR FINANCIAL STATEMENTS OF LIMITED PARTNERSHIPS ANNOUNCED

The Commission today issued a release to announce that financial statements of limited partnership registrants included in Form 10-K reports for fiscal years ending on or after December 27, 1974, must conform to the requirement that such financial statements be presented and audited on the basis of generally accepted accounting principles. Exceptions have been granted previously to certain limited partnership registrants whose financial statements were presented and audited on a tax basis. (ASR 16)

RECEIVER APPOINTED FOR CAPITAL SYNDICATIONS INC.

The Fort Worth Regional Office announced that on September 23 Federal District Judge Eldon B. Mahon appointed John B. McClane of Fort Worth, Texas, as Receiver for Capital Syndications Incorporated, Capital Syndications Company and Capital Specialists Incorporated, all of Hurst, Texas. McClane has been serving as the Special Counsel to Capital Syndications Company, general partner of the limited partnerships organized by Capital Syndications Incorporated and Capital Specialists Incorporated, since August 9, 1974. HOLDING COMPANY ACT RELEASES

INDIANA & MICHIGAN ELECTRIC COMPANY

The SEC has issued a notice giving interested persons until October 18 to request a hearing on a proposal of Indiana & Michigan Electric Company (I&M), an electric utility subsidiary company of American Electric Power Company, a registered holding company, that I&M loan up to \$10 million to an unaffiliated company to develop a coal mine. MOTION SEEKS APPOINTMENT OF RECEIVER FOR J&B INDUSTRIES, OTHERS

The Boston Regional Office announced the filing in the U.S. District Court for Massachusetts of a motion seeking the appointment of a temporary receiver in the matter of Securities and Exchange Commission v. J&B Industries, Inc., et al. The Commission, on September 3, 1974, filed a complaint against J&B Industries, Inc. and nine other defendants alleging violations of the registration, antifraud and broker-dealer registration provisions of the securities laws in the offer and sale of Canadian land interests and investment contracts to United States residents.

The motion: (a) seeks the appointment of a temporary receive. for all assets and property in the possession of American Industrial Research Corporation, J&B Industries, Inc. and American Investment Management Company--defendants in the action brought by the Commission, and (b) requests the Court to take charge of the books and records of the foregoing defendants and to retain jurisdiction over the matter to provide any additional relief required, and (c) that the Court appoint a receiver to take charge of all funds owned by American Industrial Research Corporation, J&B Industries, Inc. and Ferroplan Aktiengesellschaft, a Liechtenstein corporation, on deposit at the City Bank and Trust Company in Boston, Massachusetts.
