PROPOSED AMENDMENTS TO FORM S-8 ANNOUNCED

**LIBRARY** 

The Commission today announced proposed amendments to Form S-8 designed to expand the availability of that form to cover specified types of employee benefit plans. Form S-8 is a short form registration statement available for the registration of securities to be issued by reporting companies in connection with certain employee benefit plans. The proposed amendments would permit the use of the form for all employee security option plans meeting certain limited conditions without reference to tax status of the plan under the Internal Revenue Code; permit plans other than those involving "stock" to be registered on Form S-8; permit the form to be available for bonus, appreciation and similar plans meeting certain limited conditions; and permit the form to be available for plans covering employees of an issuer's parent. The proposals would condition the availability of the form for option, bonus, appreciation or similar plans on the plan being in writing, specifying the eligible employees, stating the maximum aggregate number of securities that may be offered under the plan, and specifying the price at which the securities may be offered or the method of determining such price. The proposals also condition the availability of the form for such plans on stockholder approval of the plan. Issuers will have the option of registering securities on Form S-8 in accordance with the proposed amendments or existing requirements while the proposed amendments are pending. Interested persons are invited to submit comments, which should be recieved not later than December 13, 1974 to George Fitzsimmons, Secretary, 500 N. Capitol St., Washington, D.C. 20549. ## **COMMISSION ANNOUNCEMENTS**

EXTENTION OF COMMENT PERIOD FOR VARIABLE ANNUITY ILLUSTRATIONS

The SEC announced that it has extended until October 15, 1974 the time for filing comments under Release 33-5516 which proposed an amendment to the Statement of Policy to permit variable annuity illustrations based on hypothetical investment returns. # TRADING SUSPENSIONS

TRADING SUSPENDED IN AVIS, INC.

Exchange and over-the-counter trading has been suspended in all securities of Avis, Inc., a Delaware corporation located in Garden City, New York, for a ten-day period beginning October 1 and continuing through midnight (EDT) on October 10, 1974.

The suspension was initiated because of unsubstantiated rumors concerning the possible purchase of International Telephone & Telegraph Corporation's majority interest in Avis, Inc. (Rel. 34-11034)

ATLANTIC INDUSTRIES, INC. TRADING SUSPENDED

Over-the-counter trading has been suspended in the securities of Atlantic Industries, Inc., of Miami, Florida, for one ten-day period beginning on October 2 and terminating at midnight (EDT) on October 11, 1974.

The Commission initiated the suspension at the request of the company because of a lack of current and accurate financial information available to the public. The Commission has been advised that 1973 financial statements cannot be relied upon. In addition, the company is delinquent in filing its report to the Commission on Form 10-K for the year ending March 30, 1974 and therefore financial statements for 1974 are not available. ADDITIONAL ACTION ON ONE TRADING SUSPENSION

The SEC has announced the suspension of exchange and over-the-counter trading in the securities of Savoy Industries, Inc. for the further ten-day period September 3 - 12, inclusive.

# **COURT ENFORCEMENT ACTIONS**

#### IRA S. ROSENBERG ENJOINED

The SEC announced that on September 20 the Honorable Lloyd F. McMahon, United States Judge for the Southern District of New York, signed a final judgment of permanent injunction against Ira S. Rosenberg, enjoining him from violations of the antifraud provisions of the securities laws in the purchase or sale of the securities of Barbara Lynn Stores, Inc. or the securities of any other issuer.

Rosenberg consented to the entry of the judgment without admitting or denying the allegations of the Commission's complaint. The complaint filed on August 21, 1974, charged that Rosenberg had purchased 3300 shares of the common stock of Barbara Lynn Stores, Inc. while in possession of material non-public information concerning a plan whereby the company would "go private" by purchasing its outstanding securities at a price well in excess of the current market price. # INVESTMENT COMPANY ACT RELEASES

#### INVENT INCORPORATED

A notice has been issued giving interested persons until October 25 to request a hearing on an application of Invent Incorporated of Houston, Texas, an oil and gas exploration company not registered under the Act, for an order under the Act declaring that it is primarily engaged in a business other than that of investing, reinvesting, owning, holding, or trading in securities or, alternatively, for an order under the Act exempting it from all provisions of the Act. ### HOLDING COMPANY ACT RELEASES

#### GULF POWER COMPANY

An order has been issued authorizing Gulf Power Company (Gulf), subsidiary of The Southern Company, to enter into agreements with Escambia, Bay and Jackson Counties, Florida (Counties) whereby the Counties will construct for Gulf pollution control facilities financed by the Counties' issuance and sale of up to \$23.3 million of pollution control revenue bonds. As a part of this transaction, Gulf also proposed to convey to the Counties existing pollution control facilities, and to issue its own first mortgage bonds to the Counties as collateral bonds. (Rel. 35-18591 - Oct. 1)

#### METROPOLITAN EDISON COMPANY

A notice has been issued giving interested persons until October 25 to request a hearing on a proposal of General Public Utilities Corporation, and its subsidiary, Metropolitan Edison Company (Met Ed), to enter into a loan agreement with the Small Business Administration, and for Met-Ed to issue a first mortgage bond as security for the loan. # ALLEGHENY PITTSBURGH COAL COMPANY

An order has been issued authorizing West Penn Power Company, subsidiary of Allegheny Power System, Inc. (APS), to sell half its interest in Allegheny Pittsburgh Coal Company, a subsidiary of West Penn, to two other APS subsidiaries and authorizing certain open account advances to the coal company to enable it to purchase a coal mine.
