The Commission has revoked the broker-dealer registration of Schreiber Bosse & Co., Inc., of Cleveland, barred Richard H. Schreiber, its president, and Thomas D. Bosse, board chairman, from association with any broker-dealer, and suspended Walter Manson, the firm's former secretary, from any such association for 30 days beginning December 2.

The sanctions imposed were based on findings that, at various times during the period June 1971 to May 1973, the firm, Schreiber and Bosse failed to comply with net capital, recordkeeping and reporting requirements.
