COMMISSION ANNOUNCEMENTS

COMMISSIONER GRUNDFEST RESIGNS

The Commission today announced that Joseph A. Grundfest has resigned from the Commission, effective January 18, 1990.

CIVIL PROCEEDINGS

U.S. GENERAL CORPORATION, WILMA JEAN CLOKE, LINDA HETTICK ENJOINED

The Fort Worth Regional office announced that on January 2 Judge David O. Belew Jr., U.S. District Court for the Northern District of Texas, permanently enjoined U.S. General Corporation, Wilma Jean Cloke, and Linda C. Hettick, all of Fort Worth, Texas. The order enjoins them from further violations of the registration, antifraud, and ownership reporting provisions of the securities laws. U.S. General Corp., Cloke, and Hettick consented to the orders without admitting or denying the Commission's allegations.

The November 21, 1989 complaint alleges that U.S. General Corp., Cloke and Hettick violated the registration and antifraud provisions by offering and selling unregistered shares of USGC. In connection with these offers and sales, the complaint alleges that defendants made false and misleading statements of material facts concerning the financial condition and business prospects of USGC, and its ownership. The complaint further alleges that Cloke failed to report beneficial ownership of more than 10 percent of USGC stock. (SEC v. U.S. General Corp., et al., USDC, ND/TX, CA No. 4-89-797-K) (LR-12348)

FONDATION HAI, OTHERS TEMPORARILY RESTRAINED

The SEC today announced that the Honorable Robert J. Ward, U.S. District Judge, Southern District of New York, on January 17 temporarily restrained and enjoined Fondation Hai, Holding Protection Ltd., Robert Rossi, Unifund SAL and certain other unnamed purchasers of the common stock and options to purchase the common stock of the Rorer Group Inc. (Rorer) from violating the antifraud provisions of the federal securities law in their transactions in the Rorer securities. The Court also ordered that defendants' brokerage accounts be frozen pending a hearing on the Commission's motion for a preliminary injunction. The Commission is seeking disgorgement from the defendants of approximately \$6,000,000 in profits from their transactions in Rorer securities. The complaint also seeks permanent injunctive relief and penalties of up to three times the illegal trading profits. The Court has scheduled a hearing for January 30, 1990 on the Commission's application for preliminary injunctive relief. [SEC v. Fondation Hai, et al., USDC, SDNY, Civil Action No. 90 Civ. 0277 (SWK)] (LR-12353)

KIRK A. KNAPP PERMANENTLY ENJOINED

The Chicago Regional Office announced that on January 3, following a bench trial, the Honorable Douglas Hillman, U.S. District Court Judge for the Western District of Michigan, Southern Division, permanently enjoined Kirk A. Knapp (Knapp) from further violations of Article II, Section 3(b) of the By-Laws of the National Association of Securities Dealers, Inc. (NASD) and certain of the antifraud and anti-manipulation provisions of the federal securities laws.

The Court found that Knapp associated with an NASD member, K.A. Knapp & Co., Inc. (Knapp & Co.), while not qualified to so associate by, among other things, directing Knapp & Co.'s investment banking and underwriting activities. The Court also found that in connection with Knapp & Co.'s underwriting of the September 1987 initial public offering by Centrac Associates, Inc. (Centrac), Knapp made misrepresentations regarding the use of proceeds from the offering, caused Knapp & Co. to make improper aftermarket purchases of Centrac stock before the public distribution was complete and that Knapp directed a scheme to create the appearance that the offering was complete by placing 37% of the shares of the offering in the names of nine nominees who he knew would not pay for the shares. CRIMINAL PROCEEDINGS

CANADIAN PLEADS GUILTY

The Seattle Regional Office, Charles H. Turner, U.S. Attorney for the District of Oregon, and David F. Levi, U.S. Attorney for the Eastern District of California, announced that on January 5 Harvey Rubenstein, a Canadian citizen of Toronto, Ontario, Canada, entered guilty pleas to two counts of securities fraud and one count of wire fraud in two separate cases pending in the U.S. District Courts in Oregon and California. The transactions involved wash sales and matched orders for the purchase and sale of stock in 1982. District Court Judge Malcolm F. Marsh of Oregon received the pleas but reserved accepting them and sentencing until February 13, 1990.

The defendant had earlier entered similar pleas to the same counts, which were rejected by the Court prior to sentencing due to failure of the defendant to meet certain restitution requirements. [United States v. Harvey Rubenstein, Nos. CR 85-98 (D. Or.) and CR S. 88-268 (E.D. CA.)] (LR-12349)

LLOYD SHARP SENTENCED

The Seattle Regional Office and Robert K. Corbin, Attorney General of Arizona, announced that on October 16 Lloyd B. Sharp of Las vegas, Nevada, was convicted after a jury trial on all four counts of an indictment alleging various violations of Arizona antifraud and registration laws in connection with his activities as part of a boiler room operation selling interests in gold mines.

Sharp was sentenced to five and a quarter years on the Fraudulent Schemes and Artifices count with lesser sentences on the other counts to run concurrently. (Arizona v. Lloyd B. Sharp, Arizona Superior Court No. CR 11065) (LR-12350)

INVESTMENT COMPANY ACT RELEASES

INTEGRATED CAPITAL APPRECIATION FUND

An order has been issued on an application filed by Integrated Capital Appreciation Fund, Inc., et al., under Section 6(c) of the Investment Company Act, exempting Applicants from Section 15(a) of the Act, to allow for the implementation, without prior shareholder approval, of interim investment advisory agreements between the Investment Companies and Integrated Resources Asset Management (IRAM) and new subadvisory agreements between IRAM and Wellington Management Company. (Rel. IC-17305 - Jan. 16)

PAINEWEBBER AMERICA FUND

A notice has been issued giving interested persons until February 12 to request a hearing on an application filed on behalf of several investment companies sponsored by Mitchell Hutchins Asset Management Inc. or PaineWebber Incorporated (PaineWebber Funds), for an order under Section 17(d) of the Investment Company Act and Rule 17d-1 permitting the PaineWebber Funds to deposit uninvested cash balances into one or more joint trading accounts to be used for investments in repurchase agreements. (Rel. IC-17306 - Jan. 16)

CONNECTICUT BANK AND TRUST COMPANY IRA COLLECTIVE INVESTMENT FUND

A notice has been issued giving interested persons until February 15 to request a hearing on an application filed by The Connecticut Bank and Trust Company IRA Collective Investment Fund for an order of the Commission under Section 8(f) of the Investment Company Act, declaring that it has ceased to be an investment company. (Rel. IC-17307- Jan. 17)

HOLDING COMPANY ACT RELEASES

COLUMBIA GAS SYSTEM AMERICAN ELECTRIC POWER COMPANY EAST OHIO GAS COMPANY

Notices have been issued giving interested persons until February 5 to request a hearing on proposals by: the COLUMBIA GAS SYSTEM, INC. to acquire, through December 31, 1991, on the open market up to 900,000 shares of its outstanding common stock (\$10 par) and to reissue such stock to fulfill stock options exercised under its Long-Term Incentive Plan, to fulfill stock purchase requirements under its Dividend Reinvestment Plan; AMERICAN ELECTRIC POWER COMPANY, INC. to repurchase up to nine million shares of its common stock (\$6.50 par) through December 31, 1991; and EAST OHIO GAS COMPANY, subsidiary of Consolidated Natural Gas Company, to acquire, for \$500,000, a limited partnership interest in Cleveland Development Partnership I, a limited partnership engaged in financing for the development of real estate projects in downtown Cleveland.
