## J.S. SECURITIES AND EXCHANGE COMMISSION

#### CIVIL PROCEEDINGS

#### EVERGOOD PRODUCTS CORPORATIONS, OTHERS PERMANENTLY ENJOINED

The Commission filed an injunctive action on January 30 in the U.S. District Court for the Southern District of New York alleging that Evergood Products Corporation, aided and abetted by Sidney and Melvin Rich, the President, and Vice President of Evergood respectively, violated Sections 13(b)(2)(A) and (B) of the Exchange Act and that Sidney and Melvin Rich violated Rules 13b2-1 and 13b2-2 thereunder. The Complaint alleges that from January 1, 1983, to December 31, 1986, Evergood did not bill a particular customer for vitamins valued at approximately \$609,421. It further alleges that the Riches concealed the transaction documents from the internal accounting staff and Evergood's auditors.

Without admitting or denying the Complaint's allegations, Evergood consented to the entry of a Final Judgment permanently enjoining it from violating Sections 13(b)(2)(A) and (B) of the Exchange Act and Sidney and Melvin Rich consented, without admitting or denying the allegations, to the entry of Final Judgments permanently enjoining each from aiding and abetting violations of Sections 13(b)(2)(A) and (B) of the Exchange Act, and from violating Rules 13b2-1 and 13b2-2 thereunder. (SEC v. Evergood Products Corporation, Sidney Rich, and Melvin Rich, U.S.D.C. S.D.N.Y., Civil Action No. 90 Civ 0570 DNE) (LR-12357 and AAER- 252).

#### DAVID HELLBERG PERMANENTLY ENJOINED

David Hellberg, who was charged by the Securities and Exchange Commission with insider trading in connection with the planned acquisition of Lucky Stores Inc. by American Stores Company, consented, without admitting or denying the Commission's allegations, to a permanent injunction from future violations of Sections 10(b) and 14(e) of the Securities Exchange Act and related Rules 10b-5 and 14e-3. Pursuant to the settlement, U.S. District Judge Aldon Anderson imposed a civil penalty of \$328,844.10 under the Insider Trading Sanctions Act, but waived payment of all but \$5,000 of the penalty based upon representations by David Hellberg as to his assets and net worth.

The Complaint alleged that David Hellberg learned of American Stores' plans to make a tender offer for Lucky Stores while he was employed by American Stores. The Complaint further alleged that Gerald Hellberg then purchased 280 call options for Lucky common stock while in possession of material, nonpublic information received from his son, realizing profits of approximately \$328,844 on an investment of \$15,049.81.

The Commission's action against Gerald Hellberg is still pending. (SEC v. David Hellberg and Gerald Hellberg, D. Utah Civil Action No. 89-C-648-A). (LR-12359).

#### ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
