# ADMINISTRATIVE PROCEEDINGS

# KEVIN B. WAIDE SANCTIONED

The Commission entered an Order Making Findings and Imposing Remedial Sanctions against Kevin B. Waide (Waide), a Denver, Colorado registered representative. In entering the order, the Commission accepted an offer submitted by Waide in settlement of proceedings instituted March 23, 1990. By his offer Waide, without admitting or denying the allegations in the order for proceedings, consented to entry of the order finding that he was permanently enjoined on April 25, 1990, in the U.S. District Court for the District of Colorado, from violating Sections 5(a) and 5(c) of the Securities Act (SEC v. Dynapac, Inc., Kevin B. Waide, et al., No. 87-N-1130, U.S.D.C., D. Colo.). Waide consented to be suspended from association with any broker, dealer, investment adviser, investment company, or municipal securities dealer for a period of 90 days commencing on June 18, 1990. # PIPER JAFFRAY INVESTMENT TRUST

A notice has been issued giving interested persons until June 5 to request a hearing on an application filed by Piper Jaffray Investment Trust Inc. for an order under Section 6(c) of the Investment Company Act, granting an exemption from Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1. The requested relief would permit the applicant to impose a contingent deferred sales charge on certain

redemptions of its shares with respect to which the applicant's front-end sales load was initially waived. (Rel. IC-17482 - May 9)

WNC HOUSING TAX CREDIT FUND II, L.P.

An order has been issued on an application filed by WNC Housing Tax Credit Fund II, L.P. and WNC Financial Group, L.P., exempting a two-tier real estate limited partnership from all provisions of the Investment Company Act. (Rel. IC-17483 - May 10)
