COMMISSION ANNOUNCEMENTS

FOIA OFFICER'S DETERMINATION AFFIRMED

The Commission's General Counsel sent a letter dated May 9 to Ms. Jane Victoria Smith, affirming the FOIA Officer's decision to deny Ms. Smith's request for "investigative files concerning Donald J. Trump." The General Counsel noted that, in accordance with standard Commission practice, he would neither confirm nor deny the existence of any such investigatory files. Where investigatory files concerning a specific individual do exist, however, access may be denied, pursuant to FOIA Exemption 7(C), 5 U.S.C. 552(b)(7)(C), 17 C.F.R. 260.80(b)(7), as an unwarranted invasion of personal privacy. CIVIL PROCEEDINGS

COMPLAINT NAMES NADEL, MARTIN, LAIACONA, ACKERMAN, OTHERS

The Atlanta Regional and Miami Branch Offices announced the filing of a Complaint, on May 18, against Joel Nadel and Howard Ackerman, both of Boca Raton, Florida; Carl Martin, now incarcerated but formerly of Mapleton, Utah; James A. Laiacona, now incarcerated but formerly of Stuart, Florida; and various entities controlled by Nadel and located in Boca Raton. The complaint seeks to enjoin the defendants, directly or indirectly, from recommending the purchase of specified securities, without disclosing the receipt of compensation in exchange for making the recommendations, in violation of Section 17(b) of the Securities Act, and disgorgement of ill-gotten proceeds.

The Complaint alleges that between approximately December 1986 and December 1987, the defendant entities touted the purchase of securities without disclosing compensation received from the issuer, or affiliates of the issuer, of such securities. Martin, Laiacona and Ackerman were affiliated with the issuers and, directly or indirectly, were responsible for the delivery of the undisclosed compensation to Nadel or entities under his control. SUNSTRAND CORPORATION PERMANENTLY ENJOINED

The Chicago Regional Office announced the filing of a Complaint on May 21 in the U.S. District Court for the Northern District of Illinois, Western Division, seeking a permanent injunction against Sundstrand Corporation (Sundstrand) and ancillary relief, involving the appointment of a committee. The Complaint alleged that from January 1, 1980 to January 1, 1987 Sundstrand violated the reporting and accounting provisions of the federal securities laws in that Sundstrand (1) maintained its books, records and accounts to conceal the facts that it charged the U.S. Department of Defense millions of dollars in costs to which it was not entitled and that it took millions of dollars in tax write-offs to which it was not entitled and, (2) therefore, prepared inaccurate financial statements contained in its Forms 10-K and Forms 10-Q filed with the Commission. Simultaneously with the filing of the Complaint, Sundstrand, without admitting or denying the allegations, consented to the entry of a permanent injunction and the appointment of a committee which will, among other things, investigate and report whether any violations of the federal securities laws, beyond those alleged in the Complaint, arise out of the facts alleged therein. COMPLAINT NAMES JOHN J. MARSTON D/B/A/ MARSTON & ASSOCIATES, ET AL.

The Fort Worth Regional Office filed a civil injunctive action on May 23 in the U.S. District Court for the Southern District of Texas against John J. Marston d/b/a Marston and Associates, Dale-Mar Drilling Company and Roger Dale Armstrong. The Complaint alleges that the defendants violated, and Dale-Mar Drilling and Armstrong aided and abetted certain of Marston's violations of the registration and antifraud provisions of the federal securities laws.

The Complaint alleges that the defendants raised at least \$6.4 million from 200 investors residing in 13 states through the offer and sale of securities in the form of investment contracts and/or limited partnership interests. It is alleged that the securities offered and sold by the defendants purportedly involved the trading of options by Marston, and the purchase of oil field equipment by Armstrong. According to the Complaint, the defendants offered and sold the securities through false representations and omissions of material facts concerning, among other things, the use of proceeds, the security of the investment, and the expected rate of return. The Complaint seeks injunctive and additional relief from the Court in the form of an accounting and disgorgement. [SEC v. John J. Marston, et al., Civil Action H-90-1720, USDC/SD/TX/Houston Div.] (LR-12491)

CRIMINAL PROCEEDINGS

WILLIAM H. BARTLETT, RICK E. MYERS FOUND GUILTY

The Chicago Regional Office and the U.S. Attorney for the Western District of Michigan announced that, on April 13, William H. Bartlett was sentenced to three years imprisonment after pleading guilty to one count of mail fraud and that, on May 7, Rick E. Myers was sentenced to three years supervised probation after he was found guilty of mail fraud following a jury trial. A condition of Myers' probation is that he not engage in the offer or sale of securities nor associate with any regulated entity. Previously, the Chicago Regional office obtained orders of permanent injunction and disgorgement against Bartlett, Myers and their affiliated companies. An adminis-

trative proceeding is currently pending against Myers. [United States v. William H. Bartlett and Rick E. Myers, G89-103-02 Cr., WD MI., SD] (LR-12486)

INVESTMENT COMPANY ACT RELEASES

THE TECUMSEH FUNDS
SELECTED INVESTMENT MANAGERS SERIES FUND

Orders have been issued under Section 8(f) of the Investment Company Act declaring that THE TECUMSEH FUNDS and SELECTED INVESTMENT MANAGERS SERIES FUND have ceased to be investment companies. (Rels. IC-17512 and IC-17513, respectively - May 29)

NEORX CORPORATION

An order has been issued on an application filed by NeoRx Corporation under Section 3(b)(2) of the Investment Company Act declaring that the company is primarily engaged in a business other than that of investing, reinvesting, owning, holding or trading in securities. (Rel. IC-17511 - May 29)

HOLDING COMPANY ACT RELEASES

COLUMBIA GAS SYSTEM

An order has been issued authorizing The Columbia Gas System, Inc. (Columbia) to acquire, through December 31, 1991, on the open market up to 900,000 shares of its outstanding common stock (\$10 par) and to reissue such stock to fulfill stock options exercised under its Long-Term Incentive Plan, to fulfill stock purchase requirements under its Dividend Reinvestment Plan, and for such other purposes as may be approved by the Commission upon request by Columbia. NEW ENGLAND POWER COMPANY

A supplemental order has been issued authorizing New England Power Company, a subsidiary of New England Electric System, to execute and deliver a loan agreement in connection with the issuance of short-term pollution control revenue bonds in the aggregate principal amount of \$20 million, to partially finance the previously authorized acquisition of certain pollution control facilities in the aggregate principal amount of \$75 million. Jurisdiction has been reserved over the terms and conditions associated with the remaining \$55 million aggregate principal amount of the proposed pollution control revenue bonds. (Rel. 35-25097)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by <u>Midwest Clearing Corporation</u> (SR-MCC-89-08), which allows MCC to establish procedures for processing value position on mandatory and non-mandatory reorganizations. (Rel. 34-28050)
