# CIVIL PROCEEDINGS

## COMPLAINT NAMES DAVID SCHARDIEN

The Commission today announced the filing of a Complaint in the U.S. District Court for the District of Columbia against David Schardien (Schardien), former Vice-President of the Utility Propane Company (UPC), formerly a subsidiary of the KCS Group, Inc. In the Complaint, the Commission seeks a permanent injunction enjoining the defendant from violations of Section 14(a) of the Securities Exchange Act of 1934 and Rules 14a-3 and 14a-6 thereunder. Without admitting or denying the allegations in the Complaint, Schardien has consented to the entry of the injunction sought by the Commission.

In the Complaint, the Commission alleges that in September 1989, Schardien distributed an anonymous proxy solicitation to most of the shareholders of record of the KCS Group Inc., urging them to reject the Company's recommendation that the sale of UPC to a third party be approved. The Complaint further alleges that Schardien failed to file either the preliminary or definitive proxy materials with the Commission as required by the federal securities laws and that the materials Schardien distributed did not contain all the information required, including a statement identifying the party engaging in the solicitation. ## CRIMINAL PROCEEDINGS

# JAMES LYNN AVERETT GUILTY PLEA

The Denver Regional Office, the Salt Lake City Branch Office, and the U.S. Attorney for the District of Utah announced that, on July 5, James Lynn Averett of Salt Lake City, Utah plead guilty to a one-count felony information charging Averett with conspiracy to commit securities fraud.

Averett admitted that he planned with others to obtain all of the stock of a corporation and to engage in a controlled market manipulation to artificially raise the price of the company's stock. Averett, an attorney, admitted that his role in the scheme included the contribution of an asset, the preparation of merger documents

for a corporate acquisition and name change, the securing of a legal tradeability opinion letter, and the arrangement for the company to be listed in the "pink sheets" published by the National Quotation Bureau, Inc. The corporation to be used in the scheme was U.S.A. Medical Corporation, formerly S.M.I., Inc. [U.S. v. James Lynn Averett, USDC for the District of Utah, Central Division, Criminal Action File No. 90-CR-0129S] (LR-12563)

# INVESTMENT COMPANY ACT RELEASES

## ABT GROWTH & INCOME TRUST

A notice has been issued giving interested persons until August 28 to request a hearing on an application filed by ABT Growth and Income Trust et al. for an order pursuant to Section 17(d) of the Investment Company Act of 1940 and Rule 17d-1 thereunder, to permit the operation of a joint trading account in repurchase agreements. # BENHAM VARIABLE INSURANCE TRUST

# MACKENZIE FINANCIAL CORPORATION

A permanent order has been issued on an application filed by Mackenzie Financial Corporation and Mackenzie Investment Management Inc. (Applicants) under Section 9(c) of the Investment Company Act of 1940 exempting Applicants and future affiliates from the disqualification provisions of Section 9(a) of the Act. Absent such an exemption, Section 9(a) would prevent Applicants from engaging in certain investment company businesses due to an Order of Prohibition entered against Applicants on June 28, 1990, by the Supreme Court of Ontario, Canada. (Rel. IC-17628, July 31)

# TEMPLETON, GALBRAITH & HANSBERGER

A permanent order has been issued on an application filed by Templeton, Galbraith & Hansberger Ltd., Templeton Management Limited, Templeton Investment Counsel, Inc., Templeton Global Bond Managers, Inc., John Templeton Counselors, Inc., Templeton Funds Distributor, Inc., and Templeton Funds Annuity Company (Applicants) under Section 9(c) of the Investment Company Act of 1940 exempting Applicants and future affiliates from the disqualification provisions of Section 9(a) of the Act. Absent such an exemption, Section 9(a) would prevent Applicants from engaging in certain investment company businesses due to an Order of Prohibition entered against Applicants on June 28, 1990, by the Supreme Court of Ontario, Canada. (Rel. IC-17629, July 31)

# HOLDING COMPANY ACT RELEASES

## NORTHEAST UTILITIES

By order dated July 3 (HCAR No. 25114), Northeast Utilities (Northeast), a registered holding company, was authorized to create and acquire all the common stock of a new wholly owned subsidiary, HEC Inc., which would engage in providing energy management services to large institutional customers primarily in New England and in New York, and related financings. The initial notice, dated June 8, 1990 (HCAR No. 25102), of the filing of the application in this matter was not published in the Federal Register, as required under the Act, and a supplemental notice was issued on July 11, 1990 (HCAR No. 25102-A). A supplemental order has been issued authorizing Northeast to engage in the same transactions. (Rel. 35-25114-A)

#### THE COLUMBIA GAS SYSTEM

A notice has been issued giving interested persons until August 13 to request a hearing on a proposal by The Columbia Gas System, Inc. (Columbia), a registered holding company and certain of its subsidiaries, Columbia Gas of Ohio, Inc., Columbia Gas of Pennsylvania, Inc., Columbia Gas of Kentucky, Inc., Columbia Gas of New York, Inc., Columbia Gas of Maryland, Inc., Commonwealth Gas Services, Inc., Columbia Gas Development Corporation, Columbia Gas Development of Canada Lt., Commonwealth Propane, Inc., Columbia Propane Corporation, Columbia Gas System Service Corporation, Columbia Lng Corporation, Columbia Gas Transmission Corporation, Columbia Gulf Transmission Company (Columbia Transmission), Commonwealth Gas Pipeline Corporation, Columbia Natural Resources, Inc. and Columbia Coal Gasification Corporation, whereby Columbia Transmission would increase the amount of first mortgage bonds it can issue to Columbia through December 31, 1991 to \$625 million, and Columbia would amend its \$500 Million Credit Agreement to extend the termination date to October 5, 1993, and to add a Money Market Option to the alternate pricing provisions. # CSW CREDIT

A notice has been issued giving interested persons until August 20 to request a hearing on a proposal by Central and South West Corporation (CSW), a registered holding company, and CSW Credit, Inc., (Credit), its nonutility subsidiary company, to change Credit's ratio of debt to equity requirement to a requirement that the equity ratio be no less than 5%. # MISSISSIPPI POWER & LIGHT COMPANY

A notice has been issued giving interested persons until August 20 to request a hearing on a proposal by Mississippi Power & Light Company (MP&L), an electric publicutility subsidiary company of Entergy Corporation, a registered holding company, to institute certain programs to seek out and meet the electric utility needs of its customers. It is contemplated that the Program will be divided into four discreet areas: "Space Conditioning," "Premium Power," "Electrotechnologies" and "Field Services." (Rel. 35-25122)

## ENTERGY CORPORATION

A notice has been issued giving interested persons until August 20 to request a hearing on a proposal by Entergy Corporation (Entergy), a registered holding company, and its subsidiary companies, Arkansas Power & Light Company, Louisiana Power & Light Company and System Energy Resources, Inc. (collectively, Operating Subsidiaries), and Entergy Operations, Inc. (EOI), whereby Entergy will enter into separate Guarantee Agreements with each of the Operating Subsidiaries to guarantee the financial ability of EOI to meet its various obligations under certain nuclear power plant Operating Agreements. #### AMERICAN ELECTRIC POWER COMPANY

An order has been issued authorizing a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, to buy 2,100 shares of common stock of Ohio Valley Electric Corporation (OVEC) from Louisville Gas and Electric Company, a publicly owned gas and electric public-utility company, for a total purchase price of \$300,000. AEP's ownership interest in OVEC would increase from 42.1% to 44.2% as a result of the proposed transaction. (Rel. 35-25123)

## MCN CORPORATION

An order has been issued authorizing MCN Corporation, a public-utility holding company which is exempt from registration under Section 3(a)(1) of the Act pursuant to Rule 2, to acquire all of the outstanding common stock of Citizens Gas Fuel Company, a Michigan gas utility company. (Rel. 35-25124)
