CIVIL PROCEEDINGS

COMPLAINT NAMES ALAN MELCHIOR

The Commission announced the filing of a Complaint for Injunctive and Other Relief in the U.S. District Court for the Northern District of Texas against Far West Capital, Inc., Alan Melchior, and Far West Electric Energy Fund, L.P.

The Complaint alleges that Far West and Melchior violated Section 5(a) and (c) of the Securities Act of 1933 by offering unregistered securities in twenty oil and gas partnerships which in fact constituted one public offering. The Complaint also alleges that Far West Electric Energy Fund, L.P., in selling "blind pool" limited partnership interests, violated Section 5(b) of the Securities Act by failing to update financial information and inform investors of changes in its financial condition and results of operations upon entering into agreements to purchase three hydroelectric plants. Such sales also violated Section 17(a)(2) and (3) because the Fund failed to update the registration statement and prospectus to identify the plants and violated its undertaking to cease offers and sales in such circumstances. Finally, the Complaint alleges that sales were made by means of a registration statement in which the acquisition criteria had been materially changed. [SEC v. Melchior, et al., (USDC for N.D. LAWRENCE G. ZULIANI PERMANENTLY ENJOINED

The New York Regional Office announced the August 6 entry of a Final Consent Judgment of Permanent Injunction as to Defendant Lawrence G. Zuliani. The judgment enjoins Zuliani from violating the antifraud provisions of the federal securities laws. The injunction arose from Zuliani's role in an allegedly fraudulent \$1.5 million sale of securities of Regional Funding Corp. in 1984, while Zuliani was a supervisor and broker of the co-underwriter, Walter Capital Corp. a defunct broker-dealer then located in New York and New Jersey. Zuliani consented to the entry of the Judgment without admitting or denying the allegations against him. [SEC v. Frank R. Grillo, et al., Civil Action 89-1453 (AMW) (D.N.J.)] (LR-12572)

COMPLAINT AGAINST ANTHONY SERIVOLA AND PAUL LANDERMAN

The Seattle Regional Office filed a complaint in the U.S. District Court for the Western District of Washington seeking to permanently enjoin Anthony Serivola, aka Anthony J. Steele, Jacksonville, Florida, and Paul Landerman, Rigby, Idaho, from violating the antifraud provisions of the federal securities laws. The complaint alleges that the defendants violated the antifraud provisions of the federal securities laws in connection with the purchase of securities of DeLaurentiis Entertainment Group (DEG), a Delaware film making and entertainment corporation headquartered in Beverly Hills, California, during the month of June, 1988. defendants purchased the securities in the name of their corporation, Excoa Oil and Gas, Inc., a Colorado corporation, formerly doing business in Bellevue, Washington. The complaint further alleges that the defendants ordered DEG common stock without having the ability and intent to pay for the stock unless the price rose above the order price so that they could sell the stock and use the proceeds from the sale to pay for the original purchase, thereafter pocketing the difference, a practice commonly called "free riding." A corrected order, replacing the incorrect name, GMP Fund, with the correct name, GPM Fund has been issued under Section 8(f) of the Investment Company Act declaring that GPM Fund, Inc. has ceased to be an investment company. (Rel. IC-17619A, August 7)

A notice has been issued giving interested persons until September 4 to request a hearing on an application filed by Vanguard Municipal Bond Fund, Inc., Vanguard Bond Market Fund, Inc., Vanguard California Tax-Free Fund, Vanguard New Jersey Tax-Free Fund, Vanguard New York Insured Tax-Free Fund, Vanguard Pennsylvania Tax-Free Fund (Funds), other investment companies which are or may become members of the Vanguard Group of Investment Companies, Vanguard Money Market Reserves, Inc. (Money Market Fund), and Vanguard Group, Inc. (together with the Funds and the Money Market Fund, the Applicants) under Sections 6(c), 17(b) and 17(d) of the Investment Company Act and Rule 17d-1 thereunder for an order exempting Applicants from the provisions of Sections 17(a)(1) and (2) and 17(d) of such Act to the extent necessary (i) to allow the Funds to purchase and redeem shares of the Money Market Fund and certain other
