CALIFORNIA MUNICIPAL INCOME FUND

An order has been issued under Sections 17(b) and 17(d) of the Investment Company Act and related Rule 17d-1 exempting The Minnesota Mutual Life Insurance Company, MIMLIC Sales Corporation, MIMLIC Series Fund, Inc.
