## THE RODNEY SQUARE MULTI-MANAGER FUND

A notice has been issued giving interested persons until December 10, 1990 to request a hearing on an application filed by The Rodney Square Multi-Manager Fund (Fund) and Wilmington Trust Company for an order under (a) Section 17(b) of the Investment Company Act from the provisions of Section 17(a) of the Act, and (b) Section 17(d) of the Act and Rule 17d-1 thereunder. Applicants seek relief to permit a proposed reorganization between two series of the Fund: the Total Return Portfolio and the Value Portfolio. The Total Return Portfolio plans to acquire all or substantially all of the assets and liabilities of the Value Portfolio in exchange for Total Return Portfolio shares, which then will be distributed to the shareholders of the Value Portfolio. #### CHRISTIANA BANK OG KREDITKASSE

#### CONSOLIDATED TVX MINING CORPORATION

#### THE EMERGING GERMANY FUND

A conditional order has been issued under Section 6(c) of the Investment Company Act on an application filed by The Emerging Germany Fund Inc., a registered closed-end investment company, exempting it from the prohibitions of Section 12(d)(3) of the Act to the extent necessary to allow it to acquire securities of foreign issuers engaged in securities-related activities in accordance with the conditions of proposed amendments to Rule 12d3-1 under the Act.
