INVESTMENT COMPANY ACT RELEASES

ROYAL TANDEM LIFE INSURANCE COMPANY

An order has been issued pursuant to Sections 11(a) and 11(c) of the Investment Company Act approving exchange offers to be made in connection with an assumption reinsurance agreement. (Rel. IC-17919 - December 26)

#### MERRILL LYNCH LIFE INSURANCE COMPANY

A temporary order has been issued: (1) pursuant to Section 6(c) of the Investment Company Act exempting Merrill Lynch Life Insurance Company, Royal Tandem Life Insurance Company, Tandem Insurance Group, Inc., Merrill Lynch Variable Life Separate Account, Royal Tandem Variable Life Separate Account, Tandem Variable Life Separate Account, and Merrill, Lynch, Pierce, Fenner & Smith, Inc. (collectively, "Applicants") from the provisions of Sections 12(d)(1), 26(a)(2), and 27(c)(2) of the Act, and paragraphs (a)(2) and (b)(15) of Rule 6 2 thereunder; and (2) pursuant to Section 17(b) of the Act exempting Applicants from Section 17(a), in connection with the issuance of certain scheduled premium variable life insurance policies and flexible premium variable life insurance policies. In addition, a notice has been issued giving interested persons untal January 21, 1991 to request a hearing on applications by Applicants for an order pursuant to Sections 6(c) and 17(b) of the Act granting permanent exemptions from the above-mentioned provisions. #### MERRILL LYNCH LIFE INSURANCE COMPANY

A temporary order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Merrill Lynch Life Insurance Company, Royal Tandem Life Insurance Company, Tandem Insurance Group, Inc., Merrill Lynch Variable Life Separate Account, Royal Tandem Variable Life Separate Account, Tandem Variable Life Separate Account, and Merrill, Lynch, Pierce, Fenner & Smith, Inc. (collectively, "Applicants") from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), 26(a)(2), 27(a)(1), 27(a)(3), 27(c)(1), 27(c)(2), 27(d), 27(f) and 27(h)(3) of the Act, and Rules 6e-2, 6e-3(T) and 22c-1 thereunder, in connection with the issuance of certain scheduled premium and flexible premium variable life insurance policies. In addition, a notice has been issued giving interested persons until January 21, 1991 to request a hearing on applications by Applicants for an order pursuant to Section 6(c) of the Act granting permanent exemptions from the above-mentioned provisions. #### CENTRAL POWER & LIGHT COMPANY

An order has been issued giving each of Central Power & Light Company, Public Service Company of Oklahoma, Southwestern Electric Power Company and West Texas Utilities Company, each an electric public-utility subsidiary of Central and South West Corporation, a registered holding company, the authority to acquire and retire through December 31, 1992 up to 20% of the par value of its preferred stock and 10% of the aggregate principal amount of its first mortgage bonds issued and outstanding on September 30, 1990 in open market and negotiated transactions. #### OLS ENERGY-CHINO

A supplemental order has been issued authorizing OLS Energy-Chino (Chino), OLS Energy-Berkeley and OLS Energy-Camarillo (Camarillo), indirect subsidiaries of General Public Utilities Corporation, a registered holding company, to extend the time during which they may borrow under revolving credit agreements, which they have entered into with General Electric Capital Corporation (GECC), and notes issued thereunder, to June 30, 1991. In addition, Chino and Camarillo propose to extend to June 30, 1991 the time during which letters of credit, which they issued to GECC to secure their obligations to pay for natural gas, may be outstanding. #### THE SOUTHERN COMPANY

A supplemental order has been issued authorizing a proposal by The Southern Company (Southern), a registered holding company, and its wholly owned service company subsidiary, Southern Company Services, Inc. (Services), to extend until December 31, 1992 the time in which Services may incur indebtedness in an aggregate amount up to \$75 million at any one time outstanding pursuant to either short-term borrowings from banks or the issuance of notes to Southern, or any combination thereof, and the guaranty of notes by Southern. The Commission has reserved jurisdiction over all other borrowings and Southern's guaranty of such borrowings from January 1, 1993 though December 31, 1995, pending completion of the record. #### NEW ENGLAND ELECTRIC SYSTEM

An order has been issued authorizing New England Electric System (NEES), a registered holding company, to make, from time-to-time through December 31, 1992, one or more capital contributions to Massachusetts Electric Company (Mass-Elec), The Narragansett Electric Company (Narragansett) and Granite State Electric Company (Granite State), wholly owned electric public-utility subsidiary companies of NEES, in amounts not to exceed an aggregate of \$40 million for Mass-Elec, \$40 million for Narragansett, and \$2 million for Granite State. #### AMERICAN ELECTRIC POWER COMPANY

A supplemental order has been issued authorizing American Electric Power Company, Inc. (AEP) to extend to December 31, 1993 the time during which AEP is authorized to issue and sell up to 44 million shares of its authorized but unissued shares of common stock under an exception from competitive bidding, pursuant to its Dividend Reinvestment and Stock Purchase Plan. ### NORTHEAST UTILITIES

An order has been issued authorizing a proposal by Northeast Utilities (Northeast), a registered holding company, and its subsidiary companies, Western Massachusetts Electric Company (WMECO), The Quinnehtuk Company (Quinnehtuk), The Connecticut Light and Power Company (CL&P), Northeast Utilities Service Company (Service), Northeast Nuclear Energy Company (Nuclear), The Rocky River Realty Company (Rocky River) and Holyoke Water Power Company (Holyoke), whereby these companies seek separate authority through December 31, 1992 to issue short-term notes to the system's money pool and/or banks, to issue and sell commercial paper, to acquire short-term notes and to make open account advances, or a combination thereof, in the following maximum amounts: Northeast, \$135 million; CL&P, \$300 million; WMECO, \$95 million; Holyoke, \$2 million; Nuclear, \$50 million; Rocky River, \$55 million; Quinnehtuk, \$5 million; and Service, \$65 million. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
