ACTING CHAIRMAN UNGER SENDS LETTER TO CHAIRMAN MICHAEL OXLEY CONCERNING INVESTOR AND CAPITAL MARKETS FEE RELIEF ACT

On March 15, Acting Chairman Unger sent the following letter to Chairman Oxley in support of the proposed Investor and Capital Markets Fee Relief Act bill.

I am pleased to write in enthusiastic support of the proposed "Investor and Capital Markets Fee Relief Act" This bill, as you described it today, will provide meaningful securities fee relief to investors, market participants, and public companies, while assuring full and stable long-term funding of the Commission I commend you and Subcommittee Chairman Baker, Representatives Vito Fossella, Sue Kelly, Felix Grucci, Carolyn Maloney, and Joseph Crowley, as well as the other co-sponsors and your staff, for crafting such a considered approach to this technically complex and multi-faceted issue.

The pay parity provision is particularly important to the Commission's ability to attract and retain qualified staff. The proposed bill, together with commensurate authorization and appropriation, will help address this issue

SEC RELEASES STATEMENT ON COMILIANCE DATE FOR GRAMM-LEACH-BLILEY ACT REQUIREMENTS

Today the Commission released the following statement with regard to compliance requirements under provisions of the Gramm-Leach-Bliley Act:

We understand that questions have arisen concerning the bank broker-dealer exceptions of the Gramm-Leach-Bliley Act. Accordingly, the Commission intends to engage in rulemaking within the next few weeks to clarify certain interpretative questions. We also intend to provide additional time from the current May 12, 2001 effective date for affected banks to come into full compliance with the requirements under the Gramm-Leach-Bliley Act. As part of this process the Commission will continue discussions with interested parties as these issues are further developed. (Press Rel. 2001-31)

ENFORCEMENT PROCEEDINGS

COMMISSION INSTITUTES ADMINISTRATIVE PROCEEDING AGAINST RONALD GAISER

On March 15, the Commission instituted a public administrative proceeding against Ronald L. Gaiser (Gaiser) pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934. Simultaneous with the institution of this proceeding, Gaiser submitted an Offer of Settlement in which, while neither admitting nor denying the

Commission's findings, Gaiser consented to the entry of an Order barring him from association with any broker or dealer, with a right to reapply after one year. The Order was based on the entry of a permanent injunction in a civil action against Gaiser. The Commission's complaint alleged that Gaiser violated the registration and antifraud provisions by, among other things, omitting to disclose the actual commissions paid to him in connection with the offer and sale of the unregistered securities of three restaurant subsidiaries of Papa Holdings, Inc. (Rel. 34-44080; File No. 3-10442)

COMMISSION INSTITUTES ADMINISTRATIVE PROCEEDING AGAINST DAVID NAUGHTON

The Commission instituted a public administrative proceeding against David J. Naughton (Naughton) pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934. Simultaneous with the institution of this proceeding, Naughton submitted an Offer of Settlement in which, while neither admitting nor denying the Commission's findings, Naughton consented to the entry of an Order barring him from association with any broker or dealer, with a right to reapply after two years. The Order was based on the entry of a permanent injunction in a civil action against Naughton The Commission's complaint alleged that Naughton violater' the registration and antifraud provisions by, among other things, omitting to disclose the actual use of proceeds, including the commissions and overrides paid to him and others, from the sale of the unregistered securities of Papa Holdings, Inc. and two of its restaurant subsidiaries. SEC RECOVERS \$873,000 ON BEHALF OF ECUADORIAN CHARITY AND RELATED INDIVIDUALS IN INTERNATIONAL PRIME BANK FRAUD CASE

The Commission announced today that on March 13 the Honorable Royce C. Lamberth of the United States District Court for the District of Columbia issued an Order Directing the Distribution of Disgorgement Proceeds (Distribution Order) in an international prime bank fraud case involving Lewis A. Rivlin, a Washington D.C. attorney. The Distribution Order directs the Clerk of the Court to pay \$873,000 to the Fundacion Perez Pallarez, an Ecuadorian charity for underprivileged girls, and a group of related individuals. This money was repatriated from a Greek bank account belonging to one of the relief defendants and represents a portion of the funds stolen from investors (see also Litigation Releases Nos. 16,779 (Oct 25, 2000), 16,593 (June 15, 2000); 16,389 (Dec. 13, 1999) and 16,179 (June 8, 1999)).
