ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST JEROME WENGER

On March 27, the Commission entered an Order Instituting Administrative Proceedings Pursuant to Section 15(b) of the Securities Exchange Act of 1934 (Order) against Jerome M. Wenger (Wenger) of Bethesda, Maryland. The Order alleges that on March 15, 2000, a final judgment of permanent injunction was entered against Wenger in the United States District Court for the Southern District of Florida, *SEC v. Omnigene Development, Inc. f/k/a Omnigene Diagnostics, Inc., et al*, Case No. 98-8672-CIV-RYSKAMP (S.D. Fla.). The final judgment permanently enjoined Wenger from further violations of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The Order further alleges that Wenger participated in a classic "pump-and-dump" scheme by touting the stock of Omnigene on his radio talk show, *The Next SuperStock*, but did not disclose that he received 66,000 shares of Omnigene stock to do so. A hearing will be scheduled to determine what remedial sanctions, if any, are appropriate in the public interest. (Rel. 34-44105; File No. 3-10444)

INVESTMENT COMPANY ACT RELEASES

GOLDEN AMERICAN LIFE INSURANCE COMPANY ET AL.

A notice has been issued giving interested persons until April 16, 2001, to request a hearing on an application filed by Golden American Life Insurance Company (Golden), Separate Account B of Golden American and Directed Services, Inc. (collectively, Applicants). Applicants seek an order of the Commission, pursuant to Section 6(c) of the Investment Company Act to the extent necessary to permit the recapture of certain credits applied to premium payments made in consideration of deferred variable annuity contracts which Golden American currently issues (the Contracts) and substantially similar variable annuity contracts that Golden American may issue in the future as well as any other separate accounts of Golden American and its successors in interest that

support in the future variable annuity contracts that are similar in all material respects to the Contracts and principal underwriters of such contracts. (Rel. IC-24915 – March 26)

ING PILGRIM INVESTMENTS, LLC, ET AL.

An order has been issued on an application filed by ING Pilgrim Investments, LLC, et al., for an exemption from Sections 18(c) and 18(i) of the Investment Company Act, Rule 23c-3 under the Act, and pursuant to Section 17(d) of the Act and Rule 17d-1 under the Act. The order permits certain registered closed-end management investment companies to issue multiple classes of shares and to impose asset-based distribution fees and early withdrawal charges. (Rel. IC-24916 – March 27)

WELLS FARGO FUNDS TRUST, ET AL.

A notice has been issued giving interested persons until April 23, 2001, to request a hearing on an application filed by Wells Fargo Funds Trust, et al. for an order exempting applicants from Section 15(f)(1)(A) of the Investment Company Act. The order would permit a registered investment company not to reconstitute its board of directors following an acquisition of substantially all of the assets of three series of another registered investment company. HOLDING COMPANY ACT RELEASES

THE AES CORPORATION

The Commission has issued an order approving an application by The AES Corporation (AES), a Delaware holding company exempt from registration by order under Section 3(a)(5) of the Act, and two individuals, Dennis W. Bakke and Roger W. Sant (collectively, Applicants), in connection with a proposed acquisition of IPALCO Enterprises, Inc. (IPALCO), an Indiana holding company exempt from registration under Section 3(a)(1) of the Act by Rule 2. Through the acquisition, Applicants will indirectly acquire IPALCO's electric utility company subsidiary, Indianapolis Power & Light Company. The order grants AES an exemption from registration under Section 3(a)(5) of the Act, conditioned upon AES' divestiture of certain interests within two years of the date of consummation of the acquisition of IPALCO. (Rel. 35-27363)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-ISE-01-06) filed by the International Securities Exchange to adopt a new marketing fee to be imposed on the transactions of ISE market makers has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication is expected in the Federal Register during the week of April 2. (Rel 34-44102)

PROPOSED RULE CHANGE

The Commission noticed for comment a proposed rule change (SR-PHLX-01-08) filed by the Philadelphia Stock Exchange concerning the maintenance and retention of records with respect to payment for options order flow arrangements. Publication of the proposal is expected in the Federal Register during the week of April 2. (Rel 34-44103)

WITHDRAWAL GRANTED

An order has been issued granting the application of Interchange Integrated Orthopaedics, Inc. to withdraw its Common Stock, \$.001 par value, from listing and registration on the American Stock Exchange, effective at the opening of business on March 27, 2001. (Rel 34-44100)
