NO WORLDWIDE BAN ON VITAMIN THERAPY
IN THE INTEREST OF **M E** MILLION-POUNDPHARMACEUTICAL BUSINESS

OPEN LETTER from Dr. med. Matthias Rath

To the Members of the Codex Alimentarius Commission
To the Members of the National Parliaments
To all political decision-makers throughout the world

note with great concern that the Codex Alimentarius Commission is planning again in November 2001 to have vitamin therapies and other natural healing methods banned for millions of people throughout the world. In the interest of a million-pound market for pharmaceutical preparations that are aimed merely at symptoms, for millions of patients the right of access to effective vitamin therapies and natural healing methods, as well as the basic right to health and freedom from bodily harm, will be fundamentally violated.

The health care of millions of people worldwide is undergoing radical change. On the one side there is the pharmaceutical industry that is carrying on its million-pound trade in disease. On the other side are vitamin therapies and other effective natural healing methods that can effectively prevent and combat today's widespread diseases.

This worldwide radical change is being accelerated by the fact that the severe, and often fatal, side effects of pharmaceutical preparations are being revealed ever more clearly, as now in the case of the cholesterol-lowering agents Baycol and Lipobay from the German Bayer concern.

It is all the more irresponsible if precisely these pharmaceutical concerns now band together to suppress the superiority of vitamin therapies over pharmaceutical medicine with the force of law.

As the scientist who initiated the worldwide breakthrough in vitamin and myocardial infarction research, in the name of millions of people throughout the world I am contacting you who bear the political responsibility: reject this unethical law! The people of the world must have free access to vitamin therapies and other natural healing methods!

Worldwide muzzling decree in the interest of the pharmaceutical industry

The unscrupulous "Codex Alimentarius" plans of the international pharmaceutical concerns provide for the following monstrous measures that are to become law in all member states of the UNO, thus worldwide:

A strict ban on health claims for vitamins, minerals and other dietary supplements for the prevention or treatment of diseases. Thus, it will soon no longer be able to be said that vitamin C stabilises the arterial wall and thus prevents myocardial infarction and stroke. Yet this fact has been known for 250 years, since the discovery of vitamin deficiency as

the cause of the seafarer's disease scurvy.

* Only certain vitamins and dietary supplements may be supplied freely. Hundreds of natural substances are to be arbitrarily declared medicines, which therefore may only be marketed by the pharmaceutical industry and with excessive profit margins. The costs of health care in Europe and throughout the world will therefore explode further.

- An **artificial** upper limit for vitamins and natural substances will be arbitrarily set by an arbitrarily formed scientific body as the "recommended daily dose".
- This **muzzling** law for vitamin therapies and natural healing methods is to be pushed through worldwide by force of law. States that reject this unethical law will be punished with economic sanctions within the framework of the World Trade Organisation (**WTO**).
- Those primarily responsible for the implementation of these unethical plans are the German pharmaceutical concerns Bayer, BASF and **Hoechst** (now Aventis), who, in the last century, as organisers of "**IG Auschwitz**" and the forced labour camp there, brought want and misery over Europe and the world.

This worldwide muzzling decree in the interest of the pharmaceutical industry is a protection law in order to protect artificially a million-pound market for **pharmaceutical** preparations that have become superfluous. The main causes of this are scientific breakthroughs in vitamin research for almost all widespread diseases.

- Hardening of the arteries, the cause of **myocardial** infarction and stroke, is an early form of the seafarer's disease scurvy. I myself developed the first patented therapy in the world for the natural reversal of myocardial infarction and stroke (US patent no. **5,278,189**).
- High blood **pressure**, heart weakness, blood supply disorders in diabetics have been identified as diseases whose main cause is a deficiency of vitamins, minerals and other **bio-catalysts** in the cell metabolism of the cardiovascular system. If this knowledge is applied consistently, in future generations these diseases will be reduced to a fraction of what they are today.

Our internet site www.dr-rath-research.org, which comprehensively documents this scientific progress, is one of the **.most** visited sites for natural health worldwide. "Medline", the largest library on the internet, lists more than 10,000 studies that provide proof of the medical efficacy of vitamins and natural healing methods.

- The argument that this worldwide **muzzling** decree serves to protect consumers is a white lie in the interest of the pharmaceutical industry. The opposite is the case. In the last **10** years not a single person has died from an "overdose" of vitamins. In contrast, more than 100,000 people die every year in Europe from the known, dangerous, side effects of pharmaceutical preparations.

* The fatal side effects of pharmaceutical preparations have now risen to such an extent that they have become the fourth most common cause of death worldwide, only exceeded by myocardial infarction, cancer and stroke. As the Bayer scandal shows, the people of the world need protection from the harmful side effects of synthetic pharmaceutical preparations - not from apparent side effects of vitamins, which up to now occur only as a pharmaceutical industry "spectre".

Background to the worldwide "Codex" muzzle: A million-pound market for symptom-orientated pharmaceutical preparations is collapsing

The international pharmaceutical concerns have already suffered defeats with similar plans for muzzling laws, with global effects:

- Defeat of pharmaceutical muzzling in **1994** in the USA: As a direct reaction to my scientific discovery that myocardial infarction is an early form of the seafarer's disease scurvy, the pharmaceutical industry tried, through the health authorities in the USA, to make vitamins medicines. Millions of Americans fought against this, and pushed through the "law on vitamin freedom", the "Dietary Supplement Health and Education Act (DSHEA)". From then onwards, health claims for vitamin therapies and natural healing methods were even permitted by law. The DSHEA passed into history as the greatest defeat of the pharmaceutical concerns hitherto. - * "Codex" defeats **1996,1998,2000** worldwide: After their defeat in the USA, the pharmaceutical concerns tried to misuse

the so-called "Codex Alimentarius Commission" of the **UNO** for its own purposes. With the same fictitious arguments such as "consumer protection" and "international standardisation", vitamin therapies and natural healing methods were to be banned for all UNO member states - i.e. worldwide. In 1996, 1998 and 2000 these plans were defeated. At the last Codex meeting in Berlin, thousands of patients protested in front of the conference building, and more than half a million people had sent their protest by e-mail directly to the members of the Codex Commission.

After all these failed attempts, the same muzzling plans are now to be pushed through again at the Codex Alimentarius meeting in November 2001 in Berlin.

Do the pharmaceutical managers and their political henchmen think that the people of the world are so naïve that they will still accept their unethical plans, despite increasing numbers of deaths and rapidly decreasing credibility?

With this letter, I urge you to say "No" to the pharmaceutical cartel's Codex Alimentarius plans!

The people of the world must have free access to vital information on vitamin and other natural healing therapies!

The people of the world need consumer protection against dangerous and fatal pharmaceutical preparations, and not from natural and health-promoting vitamin therapies! The right to health of millions of people is more important than the financial interests of a handful of pharmaceutical company shareholders!

Health must become a human right!
