U.S. Department of Agriculture docket number 05-012P; Proposed rule to allow the import of poultry processed in China to the United States; a strong, if belated, protest.

Sir or Madam:

I am well aware that this comment concerning the proposed rule to allow the import of processed poultry from China is being submitted subsequent to the cut-off date. It is no doubt unrealistic to entertain the notion that allowances might be made for the fact that members of the general public are seldom made aware of such proposed rulings until the story eventually surfaces through normal media channels. Still, I feel compelled to voice my opinion. Rest assured that this won't be my only attempt to do so.

I fault your Department for failing to give this proposal the public exposure it warranted. Undoubtedly you will discover it to be of great concern to the general public once it becomes common knowledge. I confess that I suspect this "oversight" may prove to have been intentional at some administrative level.

Given the present level of concern about avian influenza, and entirely legitimate concerns about China's reliability and responsibility when it comes to taking appropriate steps to address that threat, it is incomprehensible to me that you would even consider such a ruling. Apart from the fact that this would undoubtedly have an adverse effect on our domestic poultry industry--both by

allowing yet another unfair incursion into the U.S. marketplace, and by greatly diminishing confidence in the safety of the product as a whole--it would open an entirely new and completely unnecessary avenue for avian influenza to enter our country. Even if you happen to disagree with the actual reality of those assertions, I would think you would at least be aware of how the public will perceive your actions. Believe me, the public perception of what you propose will have political consequences you would much rather not deal with.


