ENFORCEMENT PROCEEDINGS

SEC ISSUES ORDER MAKING FINDINGS AND IMPOSING A CEASE AND DESIST ORDER AGAINST GLOBAL INFORMATION SERVICES, INC. d/b/a INVESTMENT HOTLINES AND JAMES GRADY

On January 21, the Commission issued an Order Making Findings and Imposing a Cease and Desist Order (Order) against Global Information Services, Inc. d/b/a Investment Hotlines (Investment Hotlines), a Florida company, and its president James E. Grady (Grady). Order settles a pending administrative proceeding instituted against Investment Hotlines and Grady on October 27, 1998 as part of the sweep against firms and individuals touting microcap securities over the Internet and who fail to disclose their relationship with the securities' issuers. The Order finds that Investment Hotlines failed to disclose to prospective investors that it had received \$6,000 and approximately 200,000 shares of stock from eleven of the companies it featured as investment opportunities on its Web site, Investment Hotlines OnLine, between December 1995 and September 1998 in violation Section 17(b) of the Securities Act of 1933 (Securities Act). The Order directs Investment Hotlines and Grady to cease and desist from committing or causing violations and future violations of Section 17(b) of the Securities Act. SEC OBTAINS TRO AGAINST ASSURED AND HARRIS FOR STOCK FRAUD

On January 20, the Commission sued Assured International Inc. and Sam E. Harris and obtained a Temporary Restraining Order and order From February 1998 until freezing Defendants' assets. Commission obtained the Order, Defendants raised \$828,000 from the sale of Assured stock to 82 investors. The complaint alleges that investors were told that three officers controlled Assured and were never told that Harris is its President and controlled all investor Harris is a repeat securities law violator; seven states have issued orders against him for securities law violations and the National Association of Securities Dealers censured, fined, and barred him from association with any NASD member. Investors were told that Assured would use investor funds only for marketing and sales of latex products, offering expenses, working capital, and sales commissions. The complaint charges that Assured has not manufactured or distributed latex products and that Defendants misused investor funds by paying \$202,422 (24 percent) of investor

funds to Harris. The complaint seeks a preliminary and permanent injunction, disgorgement, and civil penalties against Assured and Harris for violating the antifraud provisions, Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5. COMMISSION OBTAINS ORDER OF PERMANENT INJUNCTION WITH OTHER RELIEF AGAINST RONNIE NEIHART AND SYNVION CORPORATION

The Commission announced today that on January 20 after a hearing which was consolidated with the trial on the merits, Judge Willis B. Hunt of the United States District Court for the Northern District of Georgia entered an order against Ronnie R. Neihart (Neihart) and Synvion Corporation (Synvion) permanently enjoining them from further violations of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 (Securities Act) and Sections 10(b) and 13(a) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 10b-5, 13a-1 and 13a-13 thereunder. The Court found that defendants Neihart and Synvion engaged in fraud in the offer and sale of unregistered securities in the form of Synvion common stock using misrepresentations and omissions of fact to investors.

The Court found that Neihart and Synvion effected the scheme by falsely representing that Synvions's stock would be quoted on NASDAQ, touted false representations that the company's primary assets of ETA10 supercomputers had a value of \$20 million, misrepresented the existence of contracts between Synvion and '; various corporations when no such contracts existed misrepresented that Synvion had a stock lease agreement with Prudential. The Court found that the defendants misled investors as to the status of a 1996 North Carolina cease and desist order and that Neihart used investor funds for personal items. The Court also found that Neihart and Synvion sold 11 million shares of Synvion stock to 70 investors in six states since July 1997. The Court ordered Neihart to pay disgorgement of \$961,000 with prejudgment interest and ordered Synvion to pay disgorgement in the amount of \$961,000 with prejudgment interest. The calculation of disgorgement was based upon the amount of Synvion stock sold by the defendants in the relevant period. The Court ordered Neihart to pay a civil penalty in an amount to be determined at a later date, and ordered that Neihart be permanently barred from serving as an officer or director of an issuer. The Commission did not seek a civil penalty against defendant Synvion. [SEC v. Ronnie R. Neihart and Synvion Corporation, Civil Action File No. 1:98-CV-3341-WBH, ND Ga.] (LR-16038)

INVESTMENT COMPANY ACT RELEASES

WESTERN RESERVE LIFE ASSURANCE CO. OF OHIO, ET AL.

An order has been issued pursuant to Section 26(b) of the Investment Company Act to Western Reserve Life Assurance Co. of Ohio and WRL Series Annuity Account (Account) approving the substitution of shares of the Global Portfolio of the WRL Series Fund, Inc. (Fund) for shares of the Global Sector Portfolio of the Fund which currently are held by the Account to support individual flexible premium deferred variable annuity contracts. (Rel. IC-23657 - January 20)

TELESYSTEM INTERNATIONAL WIRELESS INC.

An order has been issued under Section 6(c) of the Investment Company Act on an application filed by Telesystem International Wireless Inc. The order permits applicant and its controlled companies to engage in certain foreign telecommunications infrastructure projects without being subject to the provisions of the Act. (Rel. IC-23658; International Series Rel. 1177 - January 20)

CITYFED FINANCIAL CORPORATION

A notice has been issued giving interested persons until February 11, 1999, to request a hearing on an application filed by CityFed Financial Corp. (CityFed). The requested order would exempt CityFed from all provisions of the Act except Sections 9, 17(a) (modified as discussed in the application), 17(d) (modified as discussed in the application), 17(e), 17(f), 36 through 45, and 47 through 51 of the Act and the rules thereunder, until the earlier of one year from the date of the requested order or such time as CityFed would no longer be required to register as an investment company under the Act. The order would extend an exemption granted until February 12, 1999. (Rel. IC-23659 - January 20)
