ENFORCEMENT PROCEEDINGS

BRIAN FARLEY BARRED FROM REGULATED ENTITIES AND ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST DANIEL KOEHLER

An Order Instituting Proceedings, Making Findings and Imposing Remedial Sanctions (Order) was entered, by consent, against Brian E. Farley (Farley) barring him from association with any broker, dealer, investment adviser, investment company and municipal securities dealer. Farley neither admitted nor denied the findings of this Order, except as to the entry of an Order of Permanent Injunction entered against him on March 1, 1999 in SEC v. Omni International Trading, Inc., et al., 97 CIV 2116, D.Minn. Farley consented to the entry of this permanent injunction, without admitting or denying the allegations of the Complaint. The bar order against Farley is based on the injunction.

In addition, an Order Instituting Proceedings (Order Instituting) was entered against Daniel L. Koehler. The Order Instituting is based on the Order of Permanent Injunction and Other Equitable Relief by Default entered against Koehler on December 4, 1998 in SEC v. Omni International Trading, Inc., et al., 97 CIV 2116, D.Minn., pursuant to the Commission's Complaint. A hearing will be scheduled for the taking of evidence.

The Complaint alleged that, from in or about January 1991 through in or about February 1995, Omni and the other defendants, including Farley and Koehler, defrauded public investors through the offer and sale of over \$4 million in Omni securities. These securities were not registered with the Commission. Throughout this time period, the Complaint alleged that Farley, Koehler and the other defendants, in connection with the offer and sale of these Omni shares, made numerous misrepresentations and omitted to state material facts regarding, among other things, Omni's future revenues, the use of proceeds, the listing of Omni securities for trading on the National Association of Securities Dealers Automated Quotations system, a purported tender offer, the expected profit to be made on the tender offer and the commissions to be earned. In addition, the Complaint alleged that Farley, Koehler and others acted as an unregistered broker or dealer. (Rels. 34-41178, File No. 3-9849; 34-41179, File No. 3-9850)

INVESTMENT COMPANY ACT RELEASES

TCW GALILEO FUNDS, INC. AND TCW FUNDS MANAGEMENT, INC.

A notice has been issued giving interested persons until April 8, 1999 to request a hearing on an application filed by TCW Galileo Funds, Inc. and TCW Funds Management, Inc. for an order under section 12(d)(1)(J) of the Investment Company Act exempting applicants from section 12(d)(1)(G)(i)(II) of the Act. The order would permit a fund of funds relying on section 12(d)(1)(G) of the Act to make direct investments in securities. (Rel. IC-23739 - March 16)

HOLDING COMPANY ACT RELEASES

ROCHESTER GAS AND ELECTRIC HOLDCO

An order has been issued granting an exemption to Rochester Gas and Electric HoldCo (Holdco), a wholly owned subsidiary of Rochester Gas and Electric Corporation (RG&E), a gas and electric public utility company. Holdco will acquire RG&E and become a public utility holding company under the Public Utility Holding Company Act (Act). Holdco was granted an exemption under section 3(a)(1) of the Act from all of its provisions, except section 9(a)(2). (Rel. 35-26991)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

On January 27, 1999, the New York Stock Exchange filed with the Commission, pursuant to Rule 19b-4 under the Securities Exchange Act of 1934, a proposal (SR-NYSE-99-03) to amend NYSE Rule 431, "Margin Requirements," to, among other things, provide that short options positions that are components of certain limited risk spread strategies (box spreads, butterfly spreads, and debt and credit spreads) will be eligible for the cash account, reduce the required margin for butterfly and box spreads, reduce the required margin for certain hedged stock positions, and permit the extension of credit on options with over nine months until expiration. Publication of the notice is expected in the Federal Register during the week of March 22. (Rel. 34-41168)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted under Rule 19b-4 by the American Stock Exchange (SR-Amex-99-01) relating to

reductions in the Airline, Natural Gas, Pharmaceutical and Securities Broker Dealer Indices Values. (Rel. 34-41164)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-99-8) under Rule 19b-4 to amend paragraph 902.02(C) of the Exchange's Listed Company Manual to reduce continuing annual listing fees. Publication of the proposal is expected in the Federal Register during the week of March 22. (Rel. 34-41171)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Municipal Securities Rulemaking Board filed with the Commission a notice of filing and immediate effectiveness of a proposed rule change under Rule 19b-4 (SR-MSRB-99-01) publishing its fourth set of questions and answers concerning the interpretation of Rule G-38 on consultants. Publication of the notice is expected in the Federal Register during the week of March 22. (Rel. 34-41170)

WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until April 6, 1999, to comment on the application of FirstLink Communications, Inc., to withdraw its Common Stock, No Par Value, and its Common Stock Purchase Warrants from listing and registration on the Boston Stock Exchange. (Rel. 34-41176)

DELISTING GRANTED

An order has been issued granting the application of the American Stock Exchange to strike from listing and registration Torotel, Inc., Common Stock, \$.50 Par Value. (Rel. 34-41175)
