FEE RATE ADVISORY #6

The continuing resolution has been extended through Wednesday, November 10, 1999. Therefore, the fee rate on filings made pursuant to Section 6(b) of the Securities Act of 1933 will remain at the current rate of \$278 per \$1,000,000. Please note that when an appropriations bill is enacted, the fee rate will decrease to \$264 per \$1,000,000.
