## CIVIL PROCEEDINGS

### PATRICK MOORE AND JOAN HOSEY ENJOINED

The Chicago Regional Office announced that on October 13 Judge Shadur entered a Permanent Injunction against Patrick Moore (Moore) and Joan Hosey (Hosey) enjoining them from future violations of the antifraud provisions. Moore and Hosey consented to the entry of the injunctions.

The Commission's Complaint alleged that Moore, formerly a registered representative and trader, and Hosey, formerly Arnold Kimmes' (Kimmes) secretary and assistant, participated in a scheme to defraud with defendants Kimmes, Michael Wright and Tommy Quinn, among others, which involved, in part, the manipulation of GSS Venture Capital Corp. (GSS) and Max, Inc. (Max) common stock in the United States and abroad. Specifically, the Complaint alleges that Moore and/or Hosey caused units of GSS and Max to be purchased through nominee accounts in the IPO and, later, at the direction of the above defendants, caused GSS and Max common stock to trade at artificially high prices by buying and selling through nominee accounts, directing and coordinating the pricing of the trading, directing and directing and coordinating the quotes and substituting an arbitrary, private pricing mechanism in place of a pricing system based on the collection judgment of the market. ## HOLDING COMPANY ACT RELEASES

### ENERGY INITIATIVES

Orders have been issued authorizing Energy Initiatives, Inc. (EII), an indirect subsidiary of General Public Utilities Corporation, a registered holding company, to from time to time: (a) through March 1, 1991, make capital contributions of up to \$2,673,000 to Northeast Energy Corp., a wholly-owned subsidiary corporation (EII Sub) which has acquired all of the common stock of Northeast Cogen, Inc. (Cogen Corp), a closely-held Indiana corporation. Cogen Corp is engaged in the development of a proposed 40 MW natural gas-fired cogeneration facility in New York State, which is a qualifying facility under the Public Utility Regulatory Policies Act of 1978 (PURPA) (Rel. 35-24976) and; (b) through October 7, 1990, make capital contributions of up to \$6,950,000 to Geddes Cogeneration Corporation, a wholly-owned subsidiary corporation, which has acquired all of the general and 99% of the limited partnership interests in Onondaga Cogeneration Limited Partnership (Cogen Partnership), a New York limited partnership. Cogen Partnership is engaged in the development of a proposed 79 MW natural-gas fired cogeneration facility in Geddes, New York, which is a qualifying facility under PURPA. (Rel. 35-24977)

## LISTING, DELISTING AND UNLISTED TRADING ACTIONS

### UNLISTED TRADING SOUGHT

A notice has been issued giving interested persons an opportunity to comment on the application of the Midwest Stock Exchange for unlisted trading privileges in 16 securities solely for the purpose of trading these securities as part of a portfolio transaction traded through the MSE's Portfolio Trading System during its Secondary Trading Session. The 16 securities are all over-the-counter securities that are quoted on the National Association of Securities Dealers Automated Quotation System (NASDAQ). The stock is traded over-the-counter and is not registered on any national securities exchange. (Rel. 34-27412)

## SELF-REGULATORY ORGANIZATIONS

### NOTICE OF PROPOSED RULE CHANGE

A proposed rule change has been filed pursuant to Rule 19b-4 under the Securities Exchange Act of 1934 by: (a) the American Stock Exchange (SR-Amex-89-23) that would establish a voting rights policy for all equity securities based upon the provisions of Securities Exchange Act Rule 19c-4 and that would rescind its current rules and policies with respect to common stock voting rights (Rel. 34-27414); and (b) the Philadelphia Stock Exchange (SR-Phlx-89-50) relating to the crossing of facilitation and solicited orders on the Phlx's equity and index options floor. (Rel. 34-27415)

Publication of the proposed rules is expected to be made in the Federal Register during the week of November 6.

### APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved proposed rule changes under Section 19(b) of the Securities Exchange Act of 1934 of the following exchanges: (a) the Options Clearing Corporation (SR-OCC-89-06) to increase minimum required contributions to OCC's clearing funds (Rel. 34-27410); and (b) the Midwest Stock Exchange (SR-MSE-89-8) to increase the number of shares subject to the guaranteed pricing parameters of the BEST System from 1,099 to 2,099. (Rel. 34-27413)

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved on an accelerated basis a proposed rule change submitted by the Philadelphia Stock Exchange (SR-Phlx-89-49) that codifies regulations governing security procedures, floor employee terminations and member firm clearing arrangements. (Rel. 34-27416)
