This quarterly magazine focuses on food safety behavior trends, emerging science and research, domestic and international inspection issues, and education programs for food workers, consumers and caregivers.

The new issue showcases USDA's efforts to reach out to at-risk populations to help fight foodborne illness. Foodborne illness, a preventable and underreported disease, is a public health and economic challenge affecting both general and at-risk populations. Nearly one in five Americans fall into this category, including young children, older adults, pregnant women and those with a weakened immune system, such as people with diabetes, cancer, HIV/AIDS and transplant recipients.

FSIS will hold public meetings on April 25 and 30 to address specific issues raised by stakeholders during the development of riskbased inspection in processing.

The use of production volume data as a proxy for exposure is the topic for the meeting on April 25. The April 30 meeting will focus on the use of industry data in the risk algorithm.

Both public meetings will be held from 9 a.m. to 1 p.m., in Room 244 of the George Mason University, Arlington Campus, 3401 N. Fairfax Drive, Arlington, Va. Stakeholders will also be able to participate via audio conference.

### **Risk-Based Inspection Meeting Transcripts Available on Web Site**

FSIS has posted on its Web site transcripts from two recent public meetings on risk-based inspection (RBI) in processing.

The agency held a public meeting on April 2 to discuss the algorithm used to determine categories of inspection under RBI for processing establishments, use of public health significant noncompliance records and the proposed RBI timeline.

A technical summit on attributing illness to food, co-hosted by FSIS, the Centers for Disease Control and Prevention and the Food and Drug Administration, was held on April 5.
