DISTILLED SPIRITS PLANT - BEVERAGE/INDUSTRIAL INFORMATION

As requested, we are enclosing the necessary forms in applying for a permit to produce beverage alcohol and a permit to produce industrial alcohol. Please be sure to provide an Email address, when you submit your paperwork, for contact purposes. This will enable us to notify you when we receive your application and possibly process your paperwork more quickly. Submit the following forms to this office:

- 1. TTB F 5110.41, Registration of Distilled Spirits Plant
- 2. TTB F 5100.24, Application for Basic Permit
- 3. TTB F 5110.25, Application for Operating Permit
- 4. TTB F 5110.56, Distilled Spirits Bond (TWO ORIGINALS, NO PHOTOCOPIES)
- 5. TTB F 5000.9, Personnel Questionnaire, (SINGLE COPY) for each
 - Corporate stockholder of 10 percent or more, officer, and director,
 - Limited Liability Company (LLC) member,
 - Partner in a partnership, or
 - Individual owner
- 6. TTB F 5000.29, Environmental Information
- 7. TTB F 5000.30, Supplemental Information on Water Quality Considerations
- 8. Diagram of the premises
- 9. Signing authority. If someone will be signing the application and/or supporting documents or act on your behalf, you must submit one of the following with your application if applicable you must file:
 - TTB F 5000.8, Power of Attorney
 - TTB F 5100.1, Signing Authority for Corporate Officials, or
 - Corporate resolution or specific notification in organizational documents granting this authority

If you are filing as a sole owner and someone will sign documents on your behalf, you must file TTB Form 5000.8, Power of Attorney.

If you are filing as a partnership, you must also file:

- Copy of Partnership Agreement;
- List of the partners, including addresses, and their percentage of ownership;
- Copy of certificate of partnership where required to be filed by any State, county or municipality;
- If there is a verbal agreement rather than written partnership agreement, please provide a written statement to that effect signed by all partners. If no single partner has signing authority on behalf of the partnership, all partners must sign each form sent to this office.

If you are filing as a corporation, you must also file:

- Copy of Articles of Incorporation
- Copy of Bylaws
- List of officers, directors, and anyone holding 10 percent or more of stock, including addresses, and showing the number of shares held; and
- Copy of certificate of incorporation executed by an officer of the state in which incorporated

If you are filing as a limited liability company, you must also file:

- Copy of Articles of Organization
- Copy of Operating Agreement
- Copy of certificate of organization executed by an officer of the state in which organized
- List of members/managers, including addresses, and their percentage of interest

All applicants applying for a permit to produce beverage alcohol and a permit to produce industrial alcohol received by TTB after January 1, 2008, must also submit certain documents related to the source of funds and a lease agreement (if applicable) as described in the enclosed instructions.

We are also enclosing Industry Circular No. 2004-2 and Pay.gov User Agreement so you may file your Federal excise tax returns and monthly reports electronically through pay.gov. Please refer to www.ttb.gov/epayment.htm for additional information regarding this service.

If the premises to be used for this operation are eligible for the National Register of Historic Places, you should not begin construction or remodeling until you have contacted the State Historic Preservation Officer (see enclosed information).

The alcohol regulations can be found on our website www.ttb.gov. Click on "Code of Federal Regulations" under "Laws & Regulations" in the 'Information by Topic' area and select Part 19.

Provide a legible photocopy of the Driver's License or official State ID card of the primary contact person. A TTB representative will interview, by phone, this individual regarding the application.

Additional Information For Beverage DSPs

The following material is intended to highlight regulatory issues applicable to beverage distilled spirits plant proprietors. This information is not a substitute for the laws and regulations that govern distilled spirits plant operations that are available to you at www.ttb.gov. Please take a minute to review the following items before you begin filling out an application. It may become apparent that you are unable to comply with the necessary requirements and save you some time. It's also important to familiarize yourself with the regulatory requirements before you start into business and avoid the risk of being cited for noncompliance after you've commenced operations!

Ask yourself the following questions.

Do I have precision hydrometers and thermometers to gauge and proof my spirits? (See 27 CFR 30.22 for instrument standards and 27 CFR 19.92 for required gauges.)

Have I read the restrictions as to location for my plant under 27 CFR 19.131?

Are my premises adequately constructed and secured to protect the revenue? Do I have the necessary approved locks? (27 CFR 19.281)

Are my tanks accurately calibrated and certified as such? Are they equipped with measuring devices to accurately determine the contents? Do my tanks, scales and pipelines meet the requirements of 27 CFR Part 19, Subpart I?

Do I need a formula on Form 5110.38 for my product? (27 CFR Part 5, Subpart Ca)

Does my product meet the standard of identity for that class and type of spirits? (27 CFR 5.22)

Do I understand the mandatory label information that must appear on my bottled products and the need for Certificates of Label Approval (COLAS) from the Alcohol and Tobacco Tax and Trade Bureau (TTB)? (27 CFR Part 5, Subpart D)

Do I understand that my spirits must be bottled and packed in conformity with the standards of fill outlined in 27 CFR Part 5, Subpart E?

Do I understand that any spirits removed from my bonded premises in cases, packages, or bulk conveyances must be marked in accordance with 27 CFR Part 19, Subpart R.

Have I reviewed the provisions in 27 CFR Part 19 Subpart W with regard to the records I must maintain for my separate production, storage and processing accounts? Is my intended system of recordkeeping reliable and will my records be readily retrievable for examination by TTB investigators and auditors?

Am I prepared to make entries in the daily records on the day on which the operation or transaction takes place and in the detail required for that particular record? (27 CFR 19.731)

Am I prepared to file excise tax returns and monthly reports by their due date and in the manner prescribed by 27 CFR Part 19, Subparts P and W?

Will my business have sufficient cash flow to enable me to timely file returns and pay the excise tax (\$13.50 per proof gallon) on spirits I remove from my bonded premises for sale? Will I be able to maintain the premiums on my distilled spirits bond for as long as my plant operates?

As a plant proprietor I understand that I must take periodic inventories of my spirits (bulk and bottled) and make a record of those inventories. Losses and shortages of spirits must be explained or tax paid.

I understand TTB officers have the right of entry to make examination of the materials, equipment and facilities, and make such gauges and inventories as they deem necessary. (27 CFR 19.81)

As a distilled spirits plant proprietor I must furnish facilities and assistance to TTB officers as required. (27 CFR 19.86)

Have I contacted my State Alcohol Beverage Control Board for their licensing requirements? http://www.ttb.gov/spirits/control_board.shtml If I am in a controlled State, will I be allowed to distribute my product through the State liquor system?
