1 **ORDINANCE**

2 **ADOPTING A UNIFORM ADMINISTRATIVE CODE AND TECHNICAL CODES**
3 **PRESCRIBING MINIMUM STANDARDS REGULATING THE CONSTRUCTION,**
4 **ALTERATION, MOVING, REPAIR AND USE AND OCCUPANCIES OF**
5 **BUILDINGS AND STRUCTURES AND BUILDING SERVICE EQUIPMENT AND**
6 **INSTALLATIONS INCLUDING PLUMBING, SWIMMING POOLS, ELECTRICAL,**
7 **MECHANICAL, SIGNS, SOLAR, ENERGY CONSERVATION, BUILDING**
8 **CONSERVATION AND THE ABATEMENT OF DANGEROUS BUILDINGS WITHIN**
9 **THE CITY OF ALBUQUERQUE; PROVIDING FOR THE ISSUANCE OF PERMITS**
10 **AND COLLECTING FEES THEREFORE; REPEALING CHAPTER 14, ARTICLE 1,**
11 **ROA 1994, THE PRESENT UNIFORM ADMINISTRATIVE CODE, AND THE**
12 **PRESENT TECHNICAL CODES INCLUDING THE BUILDING CODE, THE**
13 **PLUMBING CODE, THE SWIMMING POOL CODE, THE MECHANICAL CODE,**
14 **THE SOLAR ENERGY CODE, THE ELECTRICAL CODE, PROVIDING FOR**
15 **PENALTIES FOR VIOLATION OF THE CODE; PROVIDING A SEVERABILITY**
16 **CLAUSE; PROVIDING THE EFFECTIVE DATE AND PROVIDING FOR**
17 **PUBLICATION.**

18 **BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF**
19 **ALBUQUERQUE:**

20 **Section 1. INTENT OF ORDINANCE. It is the intent of this ordinance that**
21 **the City shall recover from fees derived from Building and Safety 100% of the**
22 **full cost, including indirect charges of code enforcement activities. It shall be**
23 **the responsibility of the Mayor to review the Building and Safety income at**
24 **yearly intervals and to recommend to the Council the need to increase or**
25 **decrease fees according to the result of this review.**

1 Section 2. ADOPTION OF THE UNIFORM ADMINISTRATIVE CODE OF THE
2 CITY OF ALBUQUERQUE. The Uniform Administrative Code is hereby
3 adopted and shall serve as the administrative, organizational and enforcement
4 rules and regulations for the adopted technical codes within the City of
5 Albuquerque, New Mexico.

6 Section 3. ADOPTION OF THE TECHNICAL CODES OF THE CITY OF
7 ALBUQUERQUE. For the purpose of prescribing minimum standards
8 regulating construction and maintenance of buildings and structures,
9 including all building service equipment, and installations within the City of
10 Albuquerque, New Mexico, the following codes are hereby adopted:

11 (A) The New Mexico Building Code as adopted by the Construction
12 Industries Division of the State of New Mexico with an effective date of July 1,
13 2004;

14 (B) The 2003 International Building Code as adopted by the Construction
15 Industries Division of the State of New Mexico, including Appendix Chapters
16 B, C, E, H, I, and J, with an effective date of July 1, 2004;

17 (C) The 2003 International Residential Code as adopted by the
18 Construction Industries Division of the State of New Mexico, including
19 Appendix Chapters H, K with an effective date of July 1, 2004;

20 (D) The 2003 New Mexico Earthen Building Materials Code as adopted by
21 the Construction Industries Division of the State of New Mexico with an
22 effective date of July 1, 2004;

23 (E) The 2003 New Mexico Historic Earthen Building Code as adopted by
24 the Construction Industries Division of the State of New Mexico with an
25 effective date of July 1, 2004;

26 (F) The 2003 New Mexico Existing Building Code as adopted by the
27 Construction Industries Division of the State of New Mexico with an effective
28 date of July 1, 2004;

29 (G) The 2003 New Mexico Non-Load Bearing Straw Construction
30 Building Standards as adopted by the Construction Industries Division of the
31 State of New Mexico with an effective date of July 1, 2004;

2 and Facilities, Including Appendix Chapters: A, B, C, D, and E, as published by
3 the International Code Council;
- 4 (I) The 1997 Uniform Code for the Abatement of Dangerous Buildings as
5 published (previously) by the International Conference of Building Officials;
- 6 (J) The 2003 New Mexico Uniform Mechanical Code as adopted by the
7 Construction Industries Division of the State of New Mexico with an effective
8 date of July 1, 2004;
- 9 (K) The 2003 New Mexico Uniform Plumbing Code as adopted by the
10 Construction Industries Division of the State of New Mexico with an effective
11 date of July 1, 2004;
- 12 (L) The 2003 New Mexico Uniform Swimming Pool, Spa and Hot Tub
13 Code as adopted by the Construction Industries Division of the State of New
14 Mexico with an effective date of July 1, 2004;
- 15 (M) The 2003 New Mexico Solar Energy Code as adopted by the
16 Construction Industries Division of the State of New Mexico with an effective
17 date of July 1, 2004;
- 18 (N) The 2007 Albuquerque Energy Conservation Code; Volumes I and II;
- 19 (O) The 2005 New Mexico Electrical Code as adopted by the
20 Construction Industries Division of the State of New Mexico with an effective
21 date of July 1, 2005;
- 22 (P) The 2002 New Mexico Electrical Safety Code as adopted by the
23 Construction Industries Division of the State of New Mexico with an effective
24 date of July 1, 2004;
- 25 (Q) Errata sheets to the adopted portions of the Codes promulgated by
26 the International Code Council, International Association of Plumbing and
27 Mechanical Officials and National Electrical Code;
- 28 (R) The City of Albuquerque amendments to the New Mexico Codes
29 referred to herein are set forth as Exhibit A and incorporated by reference are
30 hereby adopted and together with the Codes in divisions (A) through (Q) of
31 this section shall be known as the Uniform Construction Codes of the City of
32 Albuquerque. From the date on which this ordinance takes effect they shall be

1 controlling within the municipal boundaries of the City of Albuquerque, New
2 Mexico.

3 Section 4. AMENDMENTS TO THE UNIFORM CODES OF THE CITY OF
4 ALBUQUERQUE. The Uniform Codes of the City of Albuquerque hereby
5 adopted may be amended or repealed in the same manner as ordinances are
6 amended or repealed.

7 Section 5. AVAILABILITY OF THE UNIFORM CONSTRUCTION CODES OF
8 THE CITY OF ALBUQUERQUE. A copy of the Uniform Administrative Code
9 and a copy of the Uniform Construction Codes of the City of Albuquerque as
10 adopted by this ordinance are on file in the Office of the City Clerk of the City
11 of Albuquerque, and are available for inspection by the public during regular
12 business hours. A copy of said codes shall be available to any individual
13 upon request and the payment of a reasonable charge as set by the Chief
14 Administrative Officer, to be not less than the actual cost per copy.

15 Section 6. BUILDING AND SAFETY DIVISION - JURISDICTION. The
16 Building and Safety Division of the Planning Department shall have
17 jurisdiction to administer the Uniform Construction Codes of the City of
18 Albuquerque for construction, alteration, moving, demolition, repair, use and
19 occupancy of buildings, structures and building service equipment.

20 Section 7. FIRE MARSHAL - JURISDICTION; APPLICATION OF FIRE CODE.

21 (A) The Fire Marshal shall have jurisdiction under the Fire Code of the
22 City of Albuquerque to test and inspect fire alarm systems and fire
23 suppression systems, including fire hydrants, fire extinguishers and sprinkler
24 systems installed in construction, alteration, moving, repair, demolition, use
25 and occupancy of buildings, structures and building service equipment. The
26 Fire Marshal shall have jurisdiction under the Fire Code as adopted by the Fire
27 Department of the City of Albuquerque as applicable to construction,
28 alteration, moving, demolition, repair, use and occupancy of buildings,
29 structures and building service equipment.

30 (B) Existing Buildings. The Fire Marshal shall have jurisdiction to
31 administer the Fire Code of the City of Albuquerque as applicable to all
32 existing structures.

1 Section 8. **CONFLICT OF CODES.** When a conflict exists in specific code
2 requirements between applicable sections of the Uniform Construction Codes
3 of the City of Albuquerque and the Fire Code of the City of Albuquerque, the
4 Uniform Construction Codes shall prevail.

5 Section 9. **PENALTIES.** Any person violating any of the provisions of this
6 code or failing or neglecting to comply with any orders issued pursuant to any
7 section thereof shall be deemed guilty of a misdemeanor and such person
8 shall be guilty of a separate offense for each and every day or portion thereof
9 during which any such violation is continued or permitted. Upon conviction of
10 any such violation, such person shall be punished by fine of not more than
11 \$500 or by imprisonment for not more than 90 days, or by both such fine and
12 imprisonment.

13 Section 10. **REPEALER.** Ordinance No. 56-1999 and No. 58-2004, adopting
14 the Uniform Administrative Code, the Building Code, the Mechanical Code, the
15 Plumbing Code, the Swimming Pool Code, the Solar Energy Code, the
16 Electrical Code, and all amendments thereto, which is compiled as Chapter 14,
17 Article 1 of the Revised Ordinances of Albuquerque, New Mexico, 1994; are
18 hereby repealed; provided, however, that nothing contained in this ordinance
19 shall, in any manner, affect pending actions for violations of Ordinance No. 56-
20 1999 or No. 58-2004 or the Codes incorporated therein as such actions shall
21 be governed by Ordinance No. 56-1999 and No. 58-2004 and the Uniform
22 Administrative and Construction Codes incorporated therein.

23 Section 11. **SEVERABILITY CLAUSE.** If any section, subsection, sentence,
24 clause, word or phrase of this ordinance is for any reason held to be
25 unconstitutional or otherwise invalid by any court of competent jurisdiction,
26 such decision shall not affect the validity of the remaining portions of this
27 ordinance. The City Council, the Governing Body of the City of Albuquerque,
28 hereby declares that it would have passed this ordinance and each section,
29 subsection, sentence, clause, word, or phrase thereof irrespective of any one
30 or more sections, subsections, sentences, clauses, words, or phrases being
31 declared unconstitutional or otherwise invalid.

1 Section 12. COMPILATION. This ordinance shall be incorporated in and
2 compiled as part of the Revised Ordinances of Albuquerque, New Mexico,
3 1994.

4 Section 13. EFFECTIVE DATE. These amendments shall be effective after
5 having been published by title and general summary.
