SUBJECT: Distribution of Public Law 95-113, Section 1445, Funding for the Evans-Allen Program at the 1890 Land-Grant Institutions, including Tuskegee University, and West Virginia State University for Fiscal Year (FY) 2008

Attached is a copy of the CSREES-OD-1088-C, Distribution of the Public Law 95-113, Section 1445, funding for the Evans-Allen Program at the 1890 Land-Grant Institutions, including Tuskegee University, and West Virginia State University for FY 2008. These funds are allocated under section 1445(b) of the National Agricultural Research, Extension, and Teaching Policy Act of 1977 (7 U.S.C. 3222(b)). The distribution also identifies funds for the Small Business Innovation Research Program, reflecting the requirement that not less than 2.50 percent of the funds be set aside for that purpose in FY 2008. Additionally, the distribution also identifies a set-aside for biotechnology risk assessment.

As stated in my April 9, 2008 memorandum, "Update on CSREES Formula Policies and Procedures," CSREES will be transitioning to Grants.gov in FY 2008 for the submission of all administrative requirements via the SF-424 Mandatory Application Forms. CSREES will be soliciting for these applications via Formula Grant Opportunities (FGOs) which will provide instructions for the completion and submission of these forms. CSREES will notify eligible institutions when the instructions and forms are available on the Grants.gov site. Therefore, there are no reporting requirements at this time. Please note that this process will not change any current reporting processes such as the Plan of Work or the Current Research Information System. The FGO for this program will be released per my April 9, 2008 memorandum.
