Final Allotment of the McIntire-Stennis Cooperative Forestry

Act Funds for Fiscal Year (FY) 2007

The final McIntire-Stennis Cooperative Forestry Act allotment to States for fiscal year (FY) 2007 is attached. The Cooperative State Research, Education, and Extension Service (CSREES) FY 2007 appropriation for this program is \$30,008,000. A portion of the appropriation (not less than 2.50 percent) has been set aside for the Small Business Innovation Research Program and another portion has been set aside for biotechnology risk assessment.

Since an eligible institution did not fully meet its offset funds requirement, \$75,000 is being reallotted from the institution's formula allocation to all other eligible institutions. Distribution of the additional funds is contingent on the other institutions certifying that they have an equal quantity of funds available and budgeted for expenditure by September 30, 2007.

A Planning & Reporting page has been established on our website to assist you in locating the requirements, due dates, and submission information for the McIntire-Stennis Research Program Formula grants and all other formula grants. The research and extension grants are organized in groups for the three types of land-grant institutions: 1862 land-grant institutions, 1862 land-grant institutions in the U.S. territories, and 1890 land-grant institutions. Since funding continues to be contingent upon meeting planning and reporting requirements, you may want to have your administrative staff bookmark the following web link for easy access to fillable forms and due dates for all formula funds:
