Executive Summary

A major personnel change will occur as the RML begins its second year of the contract. Wayne Peay, Director, announced that he will relinquish his responsibilities to Joan Stoddart, Deputy Director, effective July 1, 2007. Ms. Stoddart will become the Interim Director for the library and the RML. Mr. Peay will retire at the end of September 2007.

During the year, the RML recruited two new liaisons. John Bramble started as the Utah/ Network Membership Liaison on May 16, 2006. Mr. Bramble transferred to the RML from his position as Outreach Librarian at the Eccles Health Sciences Library. Thomas Gibbs, Technology Liaison, left the RML when his contract at the University of Kansas Medical Center ended on June 30, 2006. Rebecca Brown was hired as the Kansas/Technology Liaison and started working for the RML on February 1, 2007. Ms. Brown transferred from her position as Copyright and Document Delivery Specialist.

Trang Tran was hired as Senior Accountant for the Eccles Library and started working on January 29, 2007. She allocates .25 FTE to the RML. She replaced David Beckstrom, who left the position October 9, 2006.

The MCR measurement of accomplishments is based on the indicators established for the year 1 logic model. We met 36 of the indicators, partially met 16, and did not meet 34 out of a total of 86 indicators. For those that we did not meet, some were indicators that were intended to be accomplished later

in the contract or an estimate to be revised with the data from year 1. Despite not meeting all of our indicators, the RML made progress in meeting the four goals for this contract:

- Promote awareness of, access to, and use of biomedical information resources for health professionals and the public, with a particular emphasis on contributing to the Healthy People 2010 goal of eliminating health disparities.
- Develop, promote, and improve electronic access to health information by Network members, health professionals, and organizations providing health information to the public.
- Develop collaborations among Network members and other organizations to improve access to and sharing of biomedical information resources throughout the nation.
- Develop tools and conduct evaluation activities to understand how the products and services of the NN/LM and NLM contribute to improved access to health information by health professionals, and the public.

Advocacy

The priority of this project area was to support Network members in being able to advocate for themselves. This included support for applying for outside funding, promoting resources, and bringing the message of the value of librarians when talking to decision makers in exhibit halls.

In order to increase the number of successful proposals generated by Network members, the RML offered consultations on project planning, evaluation, and review of proposals. Consultations occurred in meetings with individuals, with project teams, and during the "Grant Writing for \$ucce\$\$" workshops. The RML promoted its consultation service through its normal communication channels (newsletter, listsery, blogs, web site), at the MCMLA annual meeting, during a "Breezing Along with the RML" broadcast, and at a Utah Health Sciences Consortium meeting.

Indicator: Liaisons will have consulted with 6 Network members on project planning and evaluation.

This indicator was met. Liaisons assisted 6 Network members in hospital and academic institutions to develop projects, strategic plans, and surveys.

Indicator: There will be an annual increase of 1 proposal, which receives consults from RML staff, funded by NLM.

This indicator was not met. MCR staff consulted on one proposal that was submitted to NLM. The proposal was not funded.

Indicator: The number of proposals funded by NLM, NN/LM, and other sources will increase by 5 each year.

Although the RML offered no subcontracts this year, this indicator was partially met. Two proposals for projects that the RML helped facilitate were funded by the Nebraska Library Commission.

Indicator: There will be an annual increase of 3 proposals submitted from class participants.

This indicator was not met. "Grant Writing for \$ucce\$\$" was offered at the end of the year. It was too soon to determine whether participants used their new skills to submit proposals.

The RML carried out a number of activities to support health sciences librarians and libraries within their institutions to address the goal of a library improvement program for hospitals that have an MLS librarian providing library services. The Missouri/ Library Advocacy Liaison, Barb Jones, chaired the MCMLA Library Advocacy Task Force, a collaborative initiative between the RML and the MLA chapter. The task force generated and distributed a survey to assess the status of hospital libraries in the region. Ms. Jones is also a member of a committee planning a study to demonstrate the value of health sciences libraries. They have begun working on core survey questions to be distributed to librarians working as informationists. Workshops and presentations were offered in the region to increase the capacity of Network members to advocate for themselves within their institutions.

Indicator: Attendance at the MCMLA 2006 advocacy class will include at least 15 librarians.

This indicator was not met. Due to poor registration, "Measuring Your Impact" was cancelled as a CE for MCMLA 2006. However, the workshop was offered in St. Louis, Missouri and attended by 12 members. "Thinking Like an MBA" was offered as a distance CE, and Keith Cogdill presented "Measuring and Communicating the Value of Library and Information Services" as a "Breezing Along with the RML" session. The combined total regional audience (80) of these offerings reached more than the 15 librarians of our indicator.

Indicator: Library managers will self report increased knowledge of RML programs and opportunities.

Two librarians in Missouri reported that they have increased their knowledge of RML programs and opportunities.

Indicator: Identify appropriate journals for articles and come up with a plan to approach them for submitting articles for publication.

This indicator was partially met. A list of journals that are read by hospital decision makers and their submission information has been compiled for all states except Utah and Wyoming.

Indicator: Liaisons will exhibit at 3 meetings attended by hospital decision makers per year.

This indicator was not met. The RML intended to exhibit at meetings where they could address hospital administrators and other hospital decision makers. Due to the decrease in the budget, this was one of the activities that were eliminated from our plan.

Assessment and Evaluation

The Assessment and Evaluation area encompasses three goals for the RML program. The first is that we develop a mechanism for evaluating regional programs; the second is that the Regional Advisory Board, representing the diversity of the region, is effective; and the third is that we recommend ways of improving health professional and consumer access to information.

RML staff document activities into the activity reporting system (ARS), linking the activity to project logic models. Through this system we are able to track the indicators of accomplishments. Betsy Kelly, Assessment and Evaluation Liaison, continued to refine

the ARS to improve reports and facilitate adding activity data. The system was revised to better connect activities with the logic model. When filing an activity report, liaisons start by selecting the appropriate goal (broad) and working through to the indicator (granular). This assures that every activity reported is associated with part of the logic model. In the past, reports were produced that had outlying activities that were not affiliated with the logic model.

Indicator: Reports from the ARS describe activities that contribute to improved access.

This indicator was met. Meeting our indicators describes how the RML contributes to improved access to health information in the region.

Indicator: NDI data is used in planning programs.

This indicator was met. The Network Data Inventory (NDI) results and the focus group results were exhaustively discussed and used to determine future programming.

Indicator: Analysis is done on collected data and the results are shared with NLM, NN/LM, and Network members and used to inform future RML programming in the region.

This indicator was met. Reports from the Network Data Inventory and focus groups were sent to NLM, posted on the MCR web site, and reviewed in "Breezing Along with the RML" sessions.

Indicator: 85% of all individuals responding to questionnaires, participating in focus groups, completing class evaluations and/or evaluating products provide data about preferences, needs, and uses of health care information.

This indicator was not met. Questions were not asked to elicit this information.

Indicator: Recommendations for improving access to information are posted to every RML communications tool at least twice a year.

This indicator was met. Recommendations were published in more than one communication medium more than once. For example, Network members looking to improve their skills received a brochure at MCMLA; they could access a list of these training sessions from our web site, or read about it in the weekly RML News.

The RML used board members to build technology capacity in the region. All board members were sent a camera and headset and liaisons assisted members in installing free software to participate in VoIP and videoconferencing sessions. Board members were oriented to the NN/LM and the MCR programs in two sessions using Adobe Acrobat Connect Professional. Those who were not able to attend a live session viewed a recording. Members were queried and responded that this is effective way to learn about the organization.

The Regional Advisory Board met three times during the year. Two of the meetings were held electronically, but not very successfully, using Festoon. The third was an in-person meeting held in Salt Lake City, Utah. Experiences of board member's involvement in emergency planning within their own organizations or communities predominated the board meetings. Former board members alerted the RML that they would like to be a more active board. To accomplish this, indicators were established to increase the opportunities that board members had to contribute to programming by increasing contact with RML staff.

Indicator: Regional Advisory Board appointments are publicized.

This indicator was met. The membership of the board is available on the MCR web site and published in Plains to Peaks Post.

Indicator: Each Advisory Board member will either make at least one suggestion or provide advice once a year to the RML or will facilitate RML contact with their constituent group as recorded in minutes or ARS.

This indicator was met either during a board meeting or in separate meetings with an RML liaison. Board member, Ira Combs, enabled continuous showing of "Following the Clues" on the main stage at the Black Family Wellness Conference. This video includes a segment where the main character obtains assistance from the librarian who searches MedlinePlus.

Indicator: Each liaison will have at least 4 contacts (email, visits, phone calls, or videoconference), concerning RML work per year, recorded in the ARS, with board members in addition to the annual meeting.

This indicator was met. Some of the Advisory Board members participated in work groups resulting in many more contacts with liaisons.

Indicator: Visit by RML staff to board member institutions when in the neighborhood.

This indicator was met. Liaisons met with board members who reside in the same state.

Indicator: Each Board member uses videoconferencing equipment to participate in at least 3 meetings.

This indicator was met. Board members participated in two orientation sessions, two board meetings, workgroup meetings, and one-on-one meetings with liaisons using videoconferencing equipment.

Community Outreach

The RML works to promote services and resources among community organizations through contacts made in the exhibit hall and through their listservs. Training is still a challenge. The majority of the Native American outreach is done through Tribal Connections Four Corners (TC4C), since two of the participating libraries are in our region and staff are members of TC4C work groups. Outreach continues with representatives who work with other tribes in Nebraska and Wyoming. The RML continues to support two Resource Libraries with their collaborative outreach.

Indicator: Two Network members will submit records to the Effective Practices Collection.

This indicator was partially met. Working with the TC4C Needs Assessment Work Group, an effective practice on "Assessing the information needs of health care providers in rural areas" was submitted. (http://nationalserviceresources.org /epicenter/practices/index.php?ep_action=view&ep_id=1235)

Indicator: Network members will provide 6 trainings a year to health care providers who work with underserved populations, who are in public health departments, or who work with HIV/AIDS patients.

This indicator was partially met. A partnership between Creighton Health Sciences Library and the Omaha Urban AHEC resulted in training offered to South Omaha clinic staff at the Creighton HSL by library staff and Siobhan Champ-Blackwell, Community Outreach Liaison. Susan Center, Librarian for the Missouri AHEC, and Ms. Jones partnered in training health professionals in rural Missouri on the MAHEC Digital Library and NLM resources.

Indicator: 6 train-the-trainer sessions will be offered at CBOs in the region.

This indicator was partially met. Training was held at the Salvation Army (Omaha, Nebraska), the Ozark Tri-County Health Care Consortium (Neosho, Missouri), and the Moab Hispanic Health Fair (Moab, Utah). Scheduling training for staff at CBOs has been a challenge. Liaisons have participated in planning meetings, exhibited, and presented at conferences in an effort to promote the benefits of RML training.

Indicator: Liaisons exhibit, present, or publish in CBO venues at least once in each state.

This indicator was met. All state liaisons exhibited at meetings attended by those who work for community based organizations. In addition, an article was published in the Nebraska Medical Association journal on cultural competence and liaisons were on the program at Cambio de Colores in Kansas City.

Indicator: MCR contact information along with product and service information will be provided to 12 new CBOs per 5-year contract.

This indicator for the contract was met in our first year. Without much effort the RML made contact with new community based organizations and provided them with information on our resources and services. The RML introduced itself to 17 organizations in year 1.

Indicator: Liaisons make presentations and visits to those serving American Indian Tribes with whom we have an existing relationship.

This indicator was met. Liaisons have established relationships with tribal librarians and health care providers in Nebraska and Wyoming. Contacts were maintained through visits, emails, and phone calls to representatives of the Omaha, Winnebago, and Wind River Tribes. Mary Henning, Wyoming Liaison, presented an overview on NLM resources to staff at the Ft. Washakie Health Center (Wyoming) and Ms. Champ-Blackwell attended "Red Rage" training (Nebraska).

Indicator: One inner city clinic staff member will be considered for the Regional Advisory Board each year.

This indicator was met. Ira Combs from the University of Nebraska Medical Associates North Omaha Clinic is a member of the board.

Indicator: 2 Resource Libraries form working partnerships with CBOs.

This indicator was met. Our expectation in year 1 was that the planning for a long term project would take place. J. Otto Lottes Health Sciences Library spent time in meetings and phone calls with various MCR staff to outline their project and identify support we could provide. The Washington University Becker Medical Library began project planning with various departments on campus. A consumer health librarian was hired in the spring to work on this partnership project. Resources from the MCRML have been compiled, and a collaboration web page is almost ready for publication.

Consumer Health

The goal for the Consumer Health project is to increase public awareness of and access to high quality electronic health information. Staff work primarily with public librarians and health professionals to achieve this goal. At meetings, presentations, and exhibits, state liaisons promoted NLM's consumer health resources. The RML exhibited at all state library association meetings. At the end of the year, Marty Magee, Nebraska/ Education Liaison, produced a CD, "So You have a Medical Question," directed at public librarians. It will be distributed at local library association meetings next year. Information Rx is being promoted at health care provider meetings to inform them of MedlinePlus and Network libraries as a reliable resource for their patients.

Three (Nebraska, Utah, and Wyoming) of the region's Go Locals are being maintained. Missouri's Community Connections was notified that they would lose state funding next year. Deb Ward, Director of the J. Otto Lottes Health Sciences Library, and Ms. Jones are looking for organizations and/or funding to support Go Local for Missouri. Go Local Missouri was the second Go Local for the nation. Nebraska Go Local received additional funding from the Nebraska Library Commission to promote Go Local and train librarians to use it.

Indicator: Resource Library web sites have links to MedlinePlus.

This indicator was met. All Resource Libraries in the region promote MedlinePlus from their web sites.

Indicator: All state library web pages will have links to NLM resources such as Go Local and the Public Library Community Partnership web site.

This indicator was met. All state library web pages have links to MedlinePlus.

Indicator: Consumer health libraries listed on MedlinePlus will increase.

This indicator was met. Eight public libraries were added to the list on MedlinePlus' "Find a Library."

Indicator: At least 6 partnerships, per contract, will be formed, one in each state.

This indicator was not met. This has been a difficult indicator to meet. The focus of this effort is to encourage partnerships between public library Network members and community organizations. Through funding by the Nebraska Library Commission two partnerships, facilitated by the RML, promoted improved access to consumer health information.

Indicator: At least four clinical sites (or physicians), in the region will participate in the Information Rx project.

This indicator was more than met. We know from NLM that at least 24 clinical sites or health care providers have ordered prescription pads to participate in the Information Rx project.

Indicator: Members will report increased expertise in PubMed or MedlinePlus usage.

This indicator was not met. Members were not assessed about whether activities of the RML increased their expertise in these two resources.

Indicator: All six states will be participating in Go Local.

This indicator was not met. The Colorado and Kansas Liaisons continue their efforts to find organizations that are willing to share responsibility for a statewide Go Local.

Education

The emphasis of the Education program is to assure the opportunity for professional development for all Network members. The RML continues to employ technology in order to relay information about resources and services and improve the skills of our Network members. "Breezing Along with the RML" was used to keep Network members current on what the RML was doing, but also to inform them about new technologies, resources available from our web site, and services that we could provide.

During "Databases on Display" and minisessions in the MCMLA exhibit hall, liaisons provided demonstrations of NLM resources that members had indicated a lack of familiarity with in the Network Data Inventory. New workshops, "Thinking Like an MBA" and on Web 2.0 technologies, were developed and successfully taught. In the second quarter we

began tracking the effectiveness of our informative sessions. A distance education tri-fold, aimed at helping librarians improve skills without leaving their offices, was developed and distributed at MCMLA. Laptops were networked to the Internet in Colorado and Utah to offer hands on training where a computer lab was unavailable.

Indicator: Multiple print resources about RML services and health information resources for special populations are distributed in the region.

This indicator was met. Multiple brochures and articles were created and promoted through different venues for minority populations and rural populations.

Indicator: 50% of members surveyed on the NDI indicate increased knowledge due to our communication mechanisms.

This indicator was not met. The Network Data Inventory is not scheduled until year 3. The RML did use our communication mechanisms to keep members up-to-date.

Indicator: Network members and librarians will have taken a class to develop a tutorial.

This indicator was not met. Ms. Magee presented a "Breezing Along with the RML" session on Moodle to introduce members to this course management tool, but no class was taught on developing tutorials.

Indicator: Usage of netLibrary will increase by 50%.

This indicator was partially met. Our baseline was 250. Ms. Magee promoted netLibrary through regular items in the RML News and distributed a brochure describing the collection. Usage increased by over 20% with 328 books borrowed this year. Our goal was to circulate 375 books.

Indicator: 50% of attendees to training sessions indicate an increase in knowledge.

This indicator was partially met. Evaluation was not done for all training sessions. When participants did have the opportunity to evaluate training, more than 50% indicated that the objectives had been met, increasing their knowledge of the topic.

Indicator: 10 unique IPs are recorded in counts taken from the MCR Tutorials web page.

This indicator was not met. The RML could not get a list of IPs for hits to the MCR Tutorials web page.

Indicator: At least one presentation per month will be added to the NTCC and the MCR web site.

This indicator was partially met. RML staff added 2 workshops and 3 brochures to the NTCC. All presentations using Adobe Acrobat Connect Professional were recorded and are available from the MCR web site.

Indicator: Liaisons will report higher usage of materials from NTCC, rather than original development of presentations.

This indicator was met. Half of the liaisons reported that they based their presentations on materials from the NTCC, rather than starting from scratch.

Indicator: Each Resource Library hosts at least one training of the NTCC.

This indicator was met. Training was held at Eccles Health Sciences Library and at Bernard Becker Medical Library this year. The RML has scheduled training at Resource Libraries for the remainder of the contract in conjunction with the MCMLA annual meeting.

Indicator: Efforts to incorporate informatics are initiated with 2 additional academic public health programs.

This indicator was partially met. Ms. Magee and other librarians at McGoogan Library of Medicine met with the School of Public Health faculty at the University of Nebraska to discuss incorporating informatics and what to include in the curriculum.

Network Membership

Several priorities were addressed by the Network Membership program this year; the renewal of members and the incorporation of Network members into the RML infrastructure. We hoped to renew all members in the region, but when we found that it required individual contact, we decided to concentrate on full members during the first year and follow up with Affiliate members in year 2. We worked to involve Network members in the RML infrastructure. Members were represented on the Advisory Board and work groups, and Resource Library staff assisted with outreach. We continue to monitor document delivery statistics to assure that all health care providers are getting access to basic services.

Indicator: 100% of Network members are contacted yearly to ensure that institutional records are updated.

This indicator was met. As part of the Network member renewal, members were emailed, list-served, and if that didn't work, phoned; to update their institutional record in DOCLINE.

Indicator: NLM reports indicate that all Resource Libraries meet the fill rate standard.

This indicator was met. The average fill rate for Resource Libraries was 78%.

Indicator: The number of libraries included on the "Serial Holdings Not Updated in the Last Year" report will decrease by 10% yearly.

This indicator was not met. Within the year the number of libraries who did not update their serial holdings in DOCLINE remained at 69.

Indicator: 25% of eligible libraries from the Potential Member List will become either full or Affiliate members.

This indicator was not met. The RML concentrated its efforts in renewing members and will undertake recruitment in another year.

Indicator: Full Network membership does not decrease in the region.

This indicator was not met. The Network membership renewal was carried out. Our membership dropped from 195 to 166. Nine libraries closed, 4 members moved to Affiliate status, and 16 members did not renew.

Indicator: NLM reports indicate that 75% of member libraries meet NLM document delivery standards.

This indicator was not met. We learned that NLM does not produce a report for this information. We will be revising this indicator next year.

Indicator: 5 libraries not using electronic delivery methods at the beginning of each year will be using electronic delivery methods at the end of the year.

This indicator was more than met. 19 additional libraries indicate in DOCLINE that they provide electronic document delivery.

Indicator: OARF records show that at least one staff member from each Resource Library is involved in an outreach activity.

This indicator was partially met. OARF records were submitted for 3 of the 8 Resource Libraries.

Indicator: The number of unaffiliated Loansome Doc users registered with Resource Libraries in the region increases annually by 5%.

This indicator was more than met. The RML presumes that most unaffiliated health care professionals would use Resource Libraries as their Loansome Doc provider. Increased registration of Loansome Doc users at Resource Libraries would thus be representative of the rest of the region. The base number at the beginning of the year for unaffiliated Loansome Doc users was 2,180. This number increased to 2,559 a 17.4% increase.

Indicator: At least one continuity of service agreement is established in each state.

This indicator was not met. The continuity of service project intends to support solo librarians who want to take time away from the library for workshops, conferences etc. Implementing this project is taking longer than expected. Not all Network members believe that this is a worthwhile activity. We have introduced the project to the region and recruited an advisory group from among those who see the advantage of the service.

Indicator: Network members will serve on the Regional Advisory Board and on work groups for NN/LM member and outreach programs.

This indicator was met. Two Resource Library directors and six librarians from full and Affiliate facilities were on the Regional Advisory Board. Network members served on work groups for the MCMLA Advocacy Task Force, Regional Licensing Consortium Advisory Group, the Technology Work Group, and the Community Outreach Work Group. In this way we actively involve members in the NN/LM infrastructure and outreach programs.

The following indicators were to be determined from the results of the Network Data Inventory to be conducted next year. They were not met:

Indicator: 75% of members surveyed on the NDI indicate increased knowledge due to Plains to Peaks Post articles, RML news, and other listsery postings.

Indicator: Health sciences librarians in the region report that RML programs support their work to improve the transfer of health care and biomedical information within their institutions.

State Outreach

The State Outreach project collects activities that do not fit in another single project area, but instead cut across many project areas. We have exhibited extensively throughout the region and have been on the program, either as speakers or poster presenters, at many of the local meetings. We continue to work on rural and public health outreach by offering training sessions to these special populations.

Indicator: Put information into ARS and count number of new listservs joined.

This indicator was met for Utah and Colorado. In these two states, liaisons receive and send out messages on listservs for libraries, public health, and multi-cultural organizations. All liaisons continue to communicate in other ways with local library organizations, public health agencies, and community based organizations.

Indicator: Network members report the MCR web site is useful for training.

This indicator was not met. Members were not queried for feedback and no member volunteered this information. Indicator: 1 article based on an RML or NLM funded project will be published in a peer-reviewed journal or one poster/paper will be presented at a workshop or conference.

This indicator was met. A needs assessment study funded in 2004 was published in the JMLA.

Indicator: NLM and other funded projects are publicized in RML publications.

This indicator was partially met. As projects are completed in the region, principal investigators are invited to write articles for the Plains to Peaks Post in order to share their accomplishments and lessons learned. There has been a backlog of projects to be reported on from the last contract. This back-log is almost finished.

Indicator: One training session will be conducted in each state on resources pertinent to rural populations with 80% reporting training was useful.

This indicator was partially met. Training was offered in each state. It is not known whether the 80% grade was met because evaluation forms were not distributed at every session.

Indicator: 6 training sessions will be conducted on public health resources with 80% reporting training was useful.

This indicator was almost met. Five training sessions were given to public health nurses, public administration health policies students, multicultural health staff, health educators, and division heads. Most sessions met the indicator of 80% of the participants finding the training useful.

Indicator: States will have a process in place to manage access to electronic public health information.

This indicator was not met.

Indicator: The MCR will be on the program of at least one national meeting and one state meeting each year.

This indicator was met. Ms. Champ-Blackwell, presented a poster, "Patient Education for Diverse Populations:
Development, Evaluation & Dissemination" at Quality Health Care for Culturally Diverse Populations sponsored by the U.S. Department of Health and Human Services in October 2006. She was instrumental in organizing a panel presentation, "Reaching Your Community with Health Information" at the annual meeting for CTCNet - Community Technology Centers Network held in July 2006.

Liaisons presented posters, lectures, or training at state library association and health provider annual meetings in each of our states.

The MCR did not fund any projects this year, so the following indicators were not met:

Indicator: 100% of RML funded outreach projects are submitted to the Effective Practices Databases.

Indicator: Project reports are reviewed and approved by liaisons.

Technology

The RML worked hard at learning and distributing information on new technologies to improve communication and improve access to health information in the region.

By the end of the year, Adobe Acrobat Connect Professional was no longer considered a new technology for experimentation, but a normal tool to be used for meetings and training; and incorporated into the RML's operations. Communication on the use of new technologies was regularly distributed through the RML News and "Breezing Along with the RML." We started offering workshops via desktop videoconferencing and Moodle. PIGs have been installed and tested at three of our Resource Libraries and we are prepared to offer our first workshop over this technology. Due to personnel issues, the RML did not accomplish as much in this project area as had been expected.

Indicator: At least 3 podcasts or other new technology based events are offered to members.

This indicator was partially met. A video interview of Ms. Champ-Blackwell using Gizmo was produced by the Digital Divide Network. (http://www.archive.org/details/siobahnchampblackwellrosetime)

Ms. Champ-Blackwell recorded an interview with Joy Voltz from Creighton University about community outreach. (http://nnlm.gov/mcr/services/podcasts/podcasts.html)

Indicator: At least 3 videobroadcast events per year are provided by the RML and/or Network members.

This indicator was met. The RML produced 15 video sessions including the monthly "Breezing Along with the RML," two overviews called "Databases on Display," and two training sessions "Introduction to Blogs and Wikis." All but one of the sessions used Adobe Acrobat Connect Professional. One of the sessions used Skype/Festoon.

Indicator: Each liaison uses alternative forms of technology to communicate with members at least once per quarter.

This indicator was met. Liaisons used alternative communication technologies with their work group members, with their Regional Advisory Board members, and in some cases when participating in MCMLA committee meetings.

Indicator: 75% of class participants indicate increased knowledge about technologies.

This indicator was met. The following information technology classes were taught this year:

"Navigating the Network Jungle"
"RSS: The New Table of Contents
Service"

"Introduction to Blogs and Wikis"

All participants indicated an increase in knowledge in their evaluation.

Indicator: Technology liaisons' efforts will contribute to an increase in connectivity of at least one institution per state over the contract period.

This indicator was met. The Technology Coordinator worked with the librarian, IT, and administration at Shriner's Hospital in Salt Lake City, Utah to be able to do videoconferencing outside of the hospital's firewall. Installation was completed as the year ended.

Indicator: Recommendations for using technology are posted to every RML communications tool at least twice a year.

This indicator was met. Recommendations have been posted on the RML News and presented in "Breezing Along with the RML."

Indicator: 5% of class participants rate the Access Grid as an effective means of conducting a class.

This indicator was not met. This indicator was written for Access Grid presentations jointly sponsored by the Pacific Southwest, South Central, and MidContinental RMLs. In the final budget negotiations, all but the MidContinental Region eliminated this activity from their annual plan. No classes were held inter-regionally.

Indicator: Each Resource Library with an Access Grid is a participating site for at least one event using the Access Grid.

Installation and successful calibration of the PIGs took longer than expected. By the end of the year, all sites had clear audio/video and the ability to share PowerPoint slides. Scheduling of the rooms in the Resource Libraries where PIGs were installed proved more difficult than expected. The first class using Access Grid technology will be held next year.

The following indicators were not met because surveys to assess the technology portion of our program were not developed.

Indicator: 75% of members responding to periodic web surveys indicate increased knowledge due to reading the web site.

Indicator: 75% of members surveyed on the NDI indicate increased knowledge due to Plains to Peaks Post articles, RML news, and other listserv postings.

Indicator: 50% of Network members surveyed indicate that they have adopted at least one new showcased technology per year.

Indicator: 75% of members that complete survey indicate that they have increased knowledge of Open Access/Scholarly Publishing.

Indicator: Technology liaisons will consult with at least 6 organizations to help them develop a connectivity plan and find funds from other sources.

Indicator: There will be an increase in resources identified and added to the NLM Directory of History of Medicine Collections or another publicly accessible database.

Regional Emergency Preparedness Planning

Ms. Hamasu attended the emergency preparedness meeting organized by OERC and held at UCLA. Ms. Hamasu volunteered the MCR to come up with a communication mechanism for librarians and others to share recommendations about responding to an emergency, personal information about who was where, their well-being, and links to resources that would be helpful to health care providers.

Emergency planning was on the agenda for two Regional Advisory Board meetings. The RML assessed the experience of board members with emergency planning and documented their current involvement with emergency planning for their organizations and communities. Members contributed ideas on roles for Network members and the RML to assist in times of emergencies.

Identifying Unique and Historical Collections

No activity was taken to address this initiative. The RML is waiting for direction from NLM as stated in the RFP.

E-licensing

The Regional Licensing Advisory Board met regularly throughout the year under the leadership of Mr. Bramble. ACP Pier was renewed and a contract with DynaMed was signed at the end of the year.

Indicator: 10% cost savings for members. We met this indicator. Members renewing ACP Pier received a savings of 59%.

Indicator: 20 additional MCR Network members will license e-resources through the MCR Regional Licensing Consortium; OR 33% of MCR Network members will license e-resources through the MCR Regional Licensing Consortium.

We expected at least 20 additional MCR Network members to license e-resources through the MCR Regional Licensing Consortium. This indicator was not met. Sixteen members offer access to ACP Pier through the consortium.

Indicator: At least 7 Network members will use resources provided by the RML to negotiate effective e-license agreements.

This indicator was not met. The RML added "Tips for Negotiating Electronic Licensing" MLA webcast and workbook to our lending library but it was not borrowed.

Indicator: Members report that products purchased through the consortia are valuable to their users.

The RML had planned to survey participants on their consortia licensing experience but ran out of time. We did not meet our indicator.

Indicator: 50 Network members from other regions will participate in the muti-regional buying consortium or libraries from the MCR and at least one other region will license e-resources through a multi-regional buying consortium.

This indicator was not met. We had planned to begin a multi-regional buying consortium. We were not ready to extend the consortium to other regions since processes were still being tested for the MCR regional consortium. The Pacific Southwest and Pacific Northwest RMLs are ready to collaborate on a multi-region consortium as soon as we have policies and procedures ready for consideration.

EFTS

RML liaisons promoted EFTS in visits to Network members, at the Utah Health Sciences Library Consortium meeting, and arranged for marketing materials to be distributed at the 2006 Midcontinental Chapter of the Medical Library Association meeting.

Indicator: The number of libraries participating in EFTS will increase by 23 per year.

This indicator was not met. We had expected that promotion would increase participation by 23. We did not meet this indicator. EFTS participation from this region increased from 389 to 391.

Indicator: Three librarians from the MCR will participate as members of the EFTS advisory group.

This indicator was met. One RML staff member and two Network members serve as members of the EFTS advisory group They are Pat Meeves, Creighton University Health Sciences Library/Learning Center; Richard E. Kammer, Olathe Medical Center Health Sciences Library; and John Bramble, MCRML.



RML Staff Outreach Activities










Annual Map: D.1 2006-2007 MCR NE




Attachment 6 Regional Map: Network Membership




Attachment 7 State Map Colorado: Network Membership





Network Membership




