

On a personal note, Margara and her husband, Angel, have two children. Margara enjoys volunteering in school activities and being involved with her children's school lives.




POP CIRCLES THE GLOBE

Those of us involved in the Paternity Opportunity Program realize the program helps children and their parents throughout California. At the state level, it has become apparent, POP is a program that has global implications. From e-mails received around the world asking about the program, to parents wanting to complete POP forms when one parent is in a foreign country, to needing POP forms to get passports for children, POP helps people all around the world.

A familiar scenario to the POP Unit is one in which a POP form is needed because the father is being deployed. The POP form plays a significant role in ensuring the child will receive health and benefit coverage while the father is overseas. To qualify for military benefits (when the father is not married to the mother) the parent must provide a copy of the child's birth certificate and a paternity declaration or a court order of paternity as proof of the father child relationship. The military requirements have led to POP forms being signed on navel ships in the Mediterranean and in combat zones.

The impact of California POP has helped people in Mexico, Germany, Brazil, the Philippines, Spain, Japan and several African nations. In one situation a POP form was signed by a father who was a citizen of Japan and the mother who was a California resident. When the father died suddenly, his extensive estate became contested and involved the legal systems of both Japan and California. One of the key elements of the case became a POP form he had completed which established the paternity of the child.

So next time you're completing a paternity form, stop and look at it carefully... your hands could be touching the next POP that eventually goes to Kazakhstan.




POP Goal for 2006

What color to paint the room? What name should we choose? How many diapers should we buy? These are just a few of the thousands of questions that run through a new parent's head during the months prior to their child being born. Many programs are available to parents to help answer these questions and the more important questions on how to best provide for their child.

The Paternity Opportunity Program (POP) has been available to over a million parents to help establish legal paternity when their child is born. Hospital staff have been the principal participants by being there not only during delivery, but to answer questions and help parents complete their POP form. With all the excitement and chaos of a new birth, some parents may not get to ask all the questions they would like to right before signing the form.

Taking that into consideration, one of the State POP Team's goals for 2006 is to make information available to parents about POP during the prenatal process. We have created a new flyer (see insert) that lets parents know that a birth certificate does not establish legal paternity. Although a birth certificate can be used to establish the identity of the person named on it, for unmarried parents, the Declaration of Paternity or a court order is the legal documentation of who a child's father is.

Adding this flyer to prenatal class literature is where the POP Team hopes to start the flow of POP information to unmarried parents. This would give them ample time to ask questions and be fully informed by the time the baby is delivered.



The state POP Team is including this form in their training and workshop sessions and has received a positive response from staff at hospitals, Planned Parenthood and the Regional Perinatal Programs of California.

POP is a team effort between Diane Collins (the Health Information Clerk) and the nursing staff, lead by OB Director Robin Fanbuena. Like a well oiled machine, the two areas of the hospital come together to fully implement the POP program.

First, the OB nurses present information on the program to unmarried parents. They require both parents watch the state video and read the blue cover sheet to be certain they understand their rights and responsibilities. questions are addressed and the form is completed and witnessed. Next Diane comes in and processes the paternity declaration. She reviews the form for completeness and accuracy, then submits the original to the state and processes the copies for the \$10 payment by the county.

It's textbook application of the paternity process done so well it looks easy to the outsider. But we know, it's the hard working staff that really makes the program work.
