FAILURE TO OBTAIN THIS RELEASE PRIOR TO ACQUIRING PRIVATE SECTOR HOUSING WILL NOT BE A REASON FOR THE HOUSING OFFICER TO APPROVE ANY REQUEST AFTER THE FACT.
