July was hot! The Pocatello Regional Airport recorded its warmest month ever in July at 75.2°F while numerous records were set across the region. A reprieve from the heat did come with the arrival of the Monsoon season, which brought some flash flooding to the Pocatello Hydrologic Service Area (HSA). The most severe flash flooding occurred in Custer County on July 17 when rainfall rates of 1.0 inch in 30 minutes and greater poured over dry soils. The flooding caused Idaho State Highway 17 to close temporarily due to three separate mudslides. Culverts are in place along Highway 17 to handle minor flash floods; however, this particular storm exceeded the culvert capacities. No injuries or property damage were reported.

## **Other Hydrologic Interests**

## Precipitation

Precipitation was hit and miss across the Pocatello HSA in July. The entire HSA received an average of 60% of normal precipitation in June for 36 of 43 reporting stations with climate data, according to Western Region Climate Center data. Only five stations received greater-than-normal amounts: Challis ASOS at 162%, Driggs at 143%, Aberdeen at 133%, Burley at 111% and Idaho Falls with 109%. In contrast, nearly one third of the stations received less than 25% of normal, with monthly low precipitation records tied at three stations: Ashton tied the record set in 1959, Picabo tied 1958 record and Shoshone tied the 1933 record.

## **River Levels & Snowpack**

River levels across the Pocatello HSA are less than 50% of normal with a number in the eastern part of the state and Central Mountains less than 10%.

## Reservoirs

The Upper Snake River reservoir system is at 33% of capacity<sup>1</sup>, down 26% from July 5, 2007<sup>2</sup>.

## Drought

All of Eastern Idaho deteriorated to D2, "Severe", on the Drought Monitor by the end of July due to the dry winter and reservoir storage declining at a rapid rate. Emergency drought declarations were issued in five more Idaho counties in July, all of which are in the Pocatello HSA. The comprehensive list follows. Note that 15 of the 16 counties are in Pocatello's HSA, with the exception being Lemhi County. Only Cassia and Power counties remain outside the declarations.
