EEO Investigations (Closures)

• The measure for FY 06 :

50% of complaints filed will be closed within the regulatory time frames.


Definitions:

A closure is an investigation where the notice of election is sent to the complainant or a case is closed by settlement, withdrawal, or dismissal.

Regulatory time frames are under 180 days, unless extended by amendment (360 days) or extension (270 days).

Informal ADR Measures

• For FY 06:

25% of all complainants who initiate an EEO contact (for purposes of seeking counseling) will participate in the ADR process.

• For FY 07:

30% of complainants who initiate an EEO contact will participate in the ADR process.

• EEO contact refers to when an EEO Counselor or an ADR Intake Officer performs the counseling duties described in Chapter 2 of MD 110. This information is reported in Part One, Section One, of Form 462.




ADR Offered to Contacts Who Filed Informal Complaints During FY 06




Formal ADR Measures


• For FY 06:

ADR is offered to 80% of complainants who file complaints, and of those offered, achieve a 25% participation rate.

 Participation rate refers to when both parties agree to enter an ADR process.




ADR Offered to Complainants Who File Formal Complaints During FY 06
