A BILL

To require certain large government contractors that receive more than 80 percent of their annual gross revenue from Federal contracts to disclose the names and salaries of their most highly compensated officers, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Government Con-
- 5 tractor Accountability Act of 2007".

SEC. 2. CERTIFICATION AND OTHER FINANCIAL DISCLO-2 SURE REQUIREMENTS FOR CERTAIN GOV-3 ERNMENT CONTRACTORS. 4 (a) REQUIREMENTS.— 5 (1) Certification or disclosure AFTER 6 AWARD OF CONTRACT.—For each contract entered 7 into by the Federal Government with a covered con-8 tractor, the contracting officer for the contract shall 9 require the contractor to submit to the contracting 10 officer, within 90 days after award of the contract, 11 one of the following: 12 (A) CERTIFICATION OF 80 PERCENT OR LESS GROSS REVENUE FROM FEDERAL CON-13 14 TRACTS.—A certification that the contractor re-15 ceived, during the fiscal year preceding the fis-16 cal year in which the contract is awarded, 80 17 percent or less of its annual gross revenues 18 from other contracts with the Federal Govern-19 ment. 20 (B) FINANCIAL DISCLOSURE.—In the case 21 of a contractor that cannot make the certifi-22 cation described in subparagraph (A), a state-23 ment disclosing the names and salaries, during 24 such preceding fiscal year, of the principal exec-25 utive officer, the principal financial officer, the

- officers or individuals, and the directors of the contractor.
- 3 (2) Annual update of financial disclo-4 SURE.—For each contract for which a statement de-5 scribed in paragraph (1)(B) is submitted, the con-6 tracting officer for the contract shall require the 7 contractor to submit, during each fiscal year in 8 which the contract is being performed (after the fis-9 cal year in which the contract is awarded), a state-10 ment containing an update of the information re-11 quired under that paragraph, covering the preceding 12 fiscal year.
- 13 (b) AVAILABILITY.—The information required to be 14 submitted pursuant to subsection (a) shall be made pub-15 licly available in searchable form through the Federal Pro-16 curement Data System (described in section 6(d)(4)(A) of 17 the Office of Federal Procurement Policy Act (41 U.S.C.
- 18 406(d)(4)(A)).
- 19 (c) COVERED CONTRACTOR.—In this Act, the term
- 20 "covered contractor" means, with respect to a fiscal year,
- 21 an individual or entity—
- (1) that received more than \$5,000,000 in an-
- 23 nual gross revenues from Federal contracts (or sub-
- 24 contracts (at any tier) under Federal contracts) for
- 25 the preceding fiscal year; and

1 (2) that is not a publicly traded company re2 quired to file periodic reports under section 13(a) or
3 15(d) of the Securities Exchange Act of 1934 (15
4 U.S.C. 78m(a), 78o(d)).
5 (d) REGULATIONS.—The Administrator of General
6 Services shall promulgate regulations to carry out this
7 Act.
