National Archives Gets A Face Lift

You may be wondering why there is scaffolding on the exterior of the National Archives Building.

We are cleaning the exterior stone façade of the National Archives Building. In July, the project moved to the Researcher entrance on Pennsylvania Avenue. Scaffolding has been erected from the portico to the roof line above the fourth floor. Crews set up protection fencing along the south edge of the planter boxes and constructed a pedestrian tunnel to the Pennsylvania Avenue entrance. The fencing and tunnel are expected to be in place July 7 through September 15.

This project is a complete restoration cleaning of all exterior limestone and granite surfaces that will enhance the aesthetic appeal of the building and identify and repair compromised and vulnerable elements of the stonework. The project is on time and progressing well. Expected completion is December 2008.

Your continued patience and cooperation while this work is underway is greatly appreciated.

Temporary Closure of the Provost Marshal General's Bureau Records

On **August 11, 2008**, some entries within RG 110 (Records of the Provost Marshal General's Bureau [Civil War]) will temporarily close. The records will be relocated from the National Archives Building in Washington, DC, to National Archives' regional locations for availability with Federal records of states within those regions.

The records will reopen for public access on December 8, 2008.



Archival Research Catalog (ARC)

New Version

A new version of the National Archives' online catalog—the Archival Research Catalog debuted on July 8, 2008. ARC now has a new look and improved navigation tools. In particular, the **Advanced Search** features work differently in the new ARC.

Searching by Record Group in New ARC

Here are some search steps for finding a Record Group description and using the new **Search Within** feature. In this example, we are searching within Record Group (RG) 428, *General Records of the Department of the Navy*.

- 1 Enter the ARC database via the yellow  button or the [Search Options](#) link on the ARC main page at www.archives.gov/research/arc/
- 2 On the Archival Descriptions Search screen, click on the link for [Advanced Search](#)
- 3 In the Description Identifier box, type 428
- 4 Scroll down and select the  filter
Click 
- 5 Check the box for **Record Group**
Note: We recommend that you do not add any other filters, such as Type of Archival Materials or Dates, at this point in your search session.
- 6 Press the  button
- 7 In your Archival Description results, click on the title link for “General Records of the Department of the Navy, 1941–2004” (RG 428).
- 8 In the Archival Description details under “Includes,” click on the link for  [Search within this Record Group](#)
- 9 An Archival Descriptions Search screen will appear with a filter for searching within “General Records of the Department of the Navy, 1941–2004.” You may conduct a Basic Search or an Advanced Search from this point. (You also may switch to a Digital Copies search to conduct your **Search Within** search.) For example, search for Philadelphia Shipyard. ARC will search within all file unit and item descriptions that belong to Record Group 428 in ARC.

Access to Archival Databases (AAD)

AAD

This past spring, we added the **National Register of Scientific and Technical Personnel Files** for the year 1954 to the Access to Archival Databases (AAD) resource. These records contain data compiled from social and natural scientists who responded to survey questionnaires sent to them by professional organizations. For example, there is a record with information about **Linus Pauling**, as submitted to the American Chemical Society, the same year he won the Nobel Prize in Chemistry.

This summer, we hope to add the **Viet Cong Initiated Incidents Files (VCIIA)** for the years 1965–68 and an updated version of the **World War II Prisoners of the Japanese Data Files**.

For those not familiar with AAD, it provides online access to a selection of NARA's electronic records from archival databases. Some of the most popular records include:

- World War II Army Enlistment Records
- Records with Unit Information on Military Personnel Who Died During the Vietnam War
- Some records of passengers who arrived at selected U.S. ports during the 19th century
- Central Foreign Policy Files for the years 1973–75

New Mailing Address for Veterans Affairs (VA) Pension FOIA Requests

Have you ever submitted a request for a Civil War or later pension application file with a "C" or "XC" number and had the slip returned telling you the file was in the custody of the Department of Veterans Affairs (VA)?

That is because the pension application files in our custody were considered "closed" about 1929. Because someone drawing a pension based on your soldier's service was still alive, the file remained in the custody of the Department of Veterans Affairs.

We recognize that we should have these files in the National Archives, and we are working with the Department of Veterans Affairs to have them transferred to us.

Currently, to obtain the file, you need to:

- 1 Write a letter to the VA Freedom of Information Officer.
- 2 State that you are requesting access to the pension file under the Freedom of Information Act.
- 3 Give them the soldier identification information that you have.
- 4 Request a BIRLS (Beneficiary Information and Records Locator System), search for the file, and ask that they retrieve it for your use.
- 5 Go to their web site for additional instructions at www.va.gov/foia/.
- 6 The VA requires that a FOIA request be in writing and signed by the requester. The request must describe the records so that it may be located with a reasonable amount of effort.
- 7 State your willingness to pay applicable fees or provide a justification to support a fee waiver.
- 8 Please include a daytime telephone number in case someone needs to contact you.
- 9 Write Freedom of Information Act Request on the envelope.
- 10 Mail your request to the FOIA/Privacy Act Officer, Veterans Benefits Administration. **The address is:**

William also worked in the research room retrieving records placed on hold by researchers, monitoring research room activities, and answering questions researchers

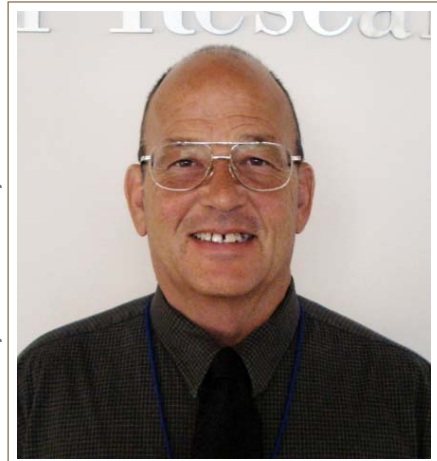

The **Know Your Records** program offers opportunities for staff, volunteers, and researchers to learn about NARA's records through lectures and genealogy programs, symposiums, the annual genealogy fair, quarterly editions of *Researcher News*, a genealogy tutorial, and the monthly **From the Records Book Group** discussions.

Lectures describe NARA's records; explain how and where to locate the records; and demonstrate how to use the records for research. Each one-hour lecture is delivered twice within the same week: on Tuesdays at the National Archives Building at 700 Pennsylvania Avenue, NW, Washington, DC; and on Thursdays at the National Archives (Archives II), located at 8601 Adelphi Road, College Park, MD. Most of these sessions are videotaped and made available for interlibrary loan through NARA libraries and our regional facilities throughout the United States.

Genealogy programs include monthly workshops and lectures from our staff archivists with extensive experience in genealogy. We provide lectures on basic genealogical research and techniques and one-on-one assistance. Some, but not all, of the genealogy programs are offered one Wednesday and one Saturday each month at the National Archives Building.

Symposiums are one to two, full-day programs on specific genealogy research topics. Past topics included Hispanic and African American genealogy information and guidance for seasoned professionals and novices alike.

The **Annual Genealogy Fair** offers a full day open house with guidance on a wide variety of genealogy research topics with NARA staff and volunteers.

The **From the Records Book Group** meets on the third Tuesday of February, March, April, September, October, and November. We will meet at 11 a.m. in Room G-24 of the National Archives Building in Washington, DC, for a discussion or film relating to the book and then, at noon, to discuss the book. Enter on Pennsylvania Avenue. The books may be purchased anywhere; the Archives Shop offers a discount to those who are participating in the book group.

The Treaty of Paris is the centerpiece of the exhibit. The original treaty, signed in 1783 by John Adams, Benjamin Franklin, and John Jay, will be on display to mark the 225th anniversary of the official ending of the American Revolutionary War.

Records on the Move

The Records of the Accounting Officers of the Department of the Treasury, Record Group (RG) 217, are returning to the National Archives Building this summer. Through a major move of 35,000 cubic feet, we will reunite this record group. *RG 217 is most notable for the settled claims of the Southern Claims Commission; the Final Pension Payment Vouchers for the Revolutionary War and the War of 1812; and the U.S. Marshals' Emolument Returns that document the service of Deputy U.S. Marshals.*

The move is scheduled to be completed on August 15, 2008. However, the settled claims of the Southern Claims Commission will not be returning right away, since they are currently being scanned for publication online in a partnership with Footnote.com. The originals will be moved to the National Archives Building after the scanning is complete. Similarly, the return of all RG 217 specially protected records items will also be delayed by a scanning project covering Abraham Lincoln items. The

scanning is being done in connection with the Abraham Lincoln Papers Project.

Some Records of the Provost Marshal General's Bureau (Civil War), RG 110, including records relating to the registration, examination, and drafting of soldiers during the Civil War, will also be moving. The consolidated lists of young men registered for the draft will remain in Washington, DC. The field office records will be reallocated to the appropriate

National Archives regional archives centers. As the 250th anniversary of the Civil War approaches, it is hoped that making these records more readily available in the various states, will make them more accessible.

The Know Your Records Program launched its book group in September 2006.

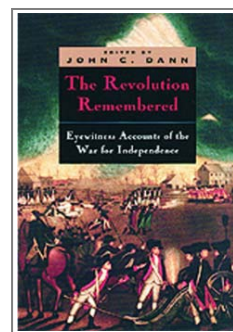

The military pension records at the National Archives provide an important source for this book.

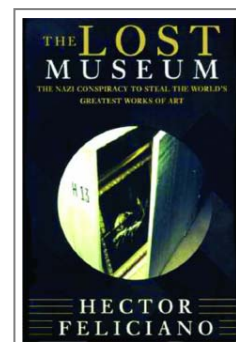

During the occupation of Paris, the Nazis confiscated nearly 100,000 artworks from more than 200 collectors, transporting most of the spoils to Germany. After the war, many works that were found were returned to their owners. But a large number had disappeared, been destroyed, or spirited out of Europe into the underground art market.

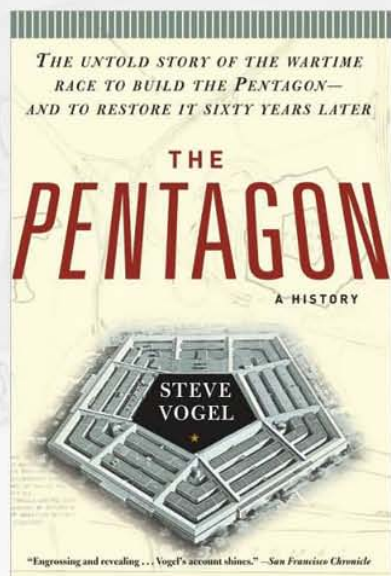
