IMPORTANT RECALL INFORMATION

The following products have recently been recalled by the Consumer Product Safety Commission (CPSC). Certain Baby Trend "Passport" Strollers are being recalled by Baby Trend, Inc. because the fold joint can collapse unexpectedly, causing the baby to fall. These Baby Trend strollers have the word "Passport" written on both sides of the canopy. Only strollers with Model Number 1514, SKN number 190554 and manufacturing dates between July 10, 2003 and November 26, 2003 are being recalled. This information is printed on the lower frame of "Passport" strollers behind the seat. The strollers were sold at Babies "R" Us from July 2003 through February 2004 for about \$29. Consumers should stop using the stroller and contact Baby Trend at (800) 328-7363 or www.babytrend.com for information about receiving a replacement stroller.

Metal Twin/Twin and Twin/Full Bunk Beds are being recalled by Coaster Co. of America because a gap between the step of the built-in ladder and the top bunk allows room for a child's body to partially slip through posing a serious strangulation risk. The recall involves model 2008, 2056, 2256 and 2258 bunk beds. The meal bunk beds were sold in twin/twin and twin/full sizes. A Coaster Company of America label is on the bed frame of the top bunk, and the enamel finishes come in blue, black, red, yellow, or white. Consumers should stop using the bunk beds immediately and contact Coaster of America at (800) 282-9362 or www.coastercompany.com for a free repair kit.

Children's Board Books with Sound Maker are being recalled by DK Publishing Inc. because the sound maker mounted inside a plastic covering on the last page of the books poses a choking hazard to young children if removed. The heavy cardboard books were sold under eight different titles that feature photos or illustrations of the title theme. The books have a raised sound button in the lower right corner, which features a sound relevant to the title. The "DK" logo is in the lower left corner of the books. Consumers should take these books away from young children immediately and contact DK Publishing at (800) 505-4726 to receive a replacement book of equal value or a refund.

"Old Century Dread Pirate™" Coffee Table Games are being recalled by Front Porch Classics because the surface coating and metal in the ships contain lead and pose a risk of lead poisoning to young children. The game has many playing pieces illustrating pirates, ships, coins, and treasure. This recall covers all games with lot numbers 75, 79, and 81. The lot numbers are on the bottom of the "treasure chest." Take the "Dread Pirate" ships away from children immediately and contact Front Porch at (800) 526-0314 or www.frontporchclassics.com for replacement toy ships.

Swings made by Backyard Products™ are being recalled by Backyard Products™ because chains on the swing can detach during use and cause the child to fall to the ground and possibly suffer injuries. This recall involves single swings and acrobatic swings sold sparately or as part of the Backyard Products wood gym set. A yellow, triangular metal gusset on the gym sets contains the brand name, "Backyard Products™ followed by "Collingwood, ON Canada." Swings can be used on other gym sets. Consumers should not let children use the swings until they have been repaired. Contact Backyard Products at (800) 841-4351 for a free, in-home repair kit.
