## Ask the Child Care Health Team...



Dear Child Care Team,

We do not allow children to play with guns in my center; however many of the children use block building, or even their fingers to "make" guns and play at shooting their peers. How can I intervene? If children are only pretending should I set limits?

#### Dear Anti-Violence,

As you know, children today live in a world where they are exposed to a variety of frightening images: through TV shows and news, videogames, and sometimes in their own communities. Preschoolers are at a vulnerable point in their development. They are just beginning to branch out from their family world to establish important peer relationships and master more formal educational settings (e.g. kindergarten).

Worried about whether they can be safe, children may resort to using guns, or pretending to be super-heroes to feel more powerful and therefore safer.



So, what can you do?

First, provide ample opportunities to support the development of children's self-competence. Let them know that they have handled themselves well when faced with challenges.

Remind children that guns are not necessary at your school because everyone is safe and that everyone is learning how to solve problems peacefully.

Diffuse gun play by naming some other things that might be "shot" from a gun. For example, "I see you are shooting and I wonder if it is delicious ice cream being sent in my direction!"

**Back Trails Jr. Bicycle Helmets** manufactured by UNA International Limited, of China, distributed by Dynacraft BSC Inc. and sold at Target Stores nationwide from April 2004 through July 2005 for about \$13.

**Red Sunglasses/Toddler Cap Set** manufactured in Taiwan, imported by Walt Disney Parks and Resorts, LLC and sold at Disneyland Resorts and Disney Cruise Line from November 2004 through June 2005 for about \$16.

**Sesame Street Toy Sunglasses** manufactured in China by American Greetings Corp. and sold at discount, toy, drug, grocery, party and specialty/gift stores nationwide from December 2003 through August 2005 for about \$3.

Surf Club<sup>™</sup> Arm Bands (children's pool floats) manufactured in China, imported by CVS Pharmacy, Inc. and sold at CVS stores nationwide from April 2003 through August 2005 for about \$1.

**Harley-Davidson 16-inch BMX Bicycles** manufactured in China, distributed by World Wide Cycle Supply Inc., and sold at Toys "R" Us stores nationwide from July 2002 through June 2005 for about \$80.

**Spindle Cribs** manufactured in Taiwan and sold at Pottery Barn Kids retail stores, the Pottery Barn Kids catalog and PotteryBarnKids.com nationwide from January 2004 through July 2005 for between \$300 and \$500.

**Certain AC Adapters sold with slim version Playstation**® made in China, imported by Sony Computer Entertainment America, Inc. and sold at electronics, toy and computer game stores nationwide, as well as Web retailers, from October 2004 through August 2005 for about \$150 for the complete system.

"Bottle Sippers" Pull-Up Bottle Caps manufactured in China by Bradshaw International, Inc. and sold at grocery stores nationwide from January 2002 through August 2005 for about \$2 per package.

**Necklace and Earring Sets** made in China, imported by Dollar General Corp., and sold at Dollar General Stores nationwide from May 2005 through August 2005 for between \$1 and \$3.

**Reebok Children's Fleece Pullover/Pant Sets** imported by Adjmi Apparel Group, and sold at Gordmans, Mervyns, JC Penney, Kohl's, The Bon, Fred Meyer, Ross, DD's, Edisons, Macy's, AJ Wright, and Reebok Corporate Headquarters from September 2004 – February 2005 for \$17 - \$36.


