ORDER OF DISMISSAL

:

This proceeding arises under the Wagner-Peyser Act of 1933, 29 U.S.C. \$49, et seq., and the regulations governing the Job Service system at 20 C.F.R. Part 658, as well as the temporary alien labor certification procedures provided for by the Immigration and Nationality Act, 8 U.S.C. \$1101, et seq., and the regulations promulgated thereunder at 20 C.F.R. Part 655.

On November 29, 1983, the Virginia Carolina Agricultural Producers Association (hereinafter "VCAPA") filed a request for administrative-judicial review of a notice of ineligibility to apply for temporary labor certification dated November 14, 1983. The sole issue raised by employer's appeal was the validity of the regulations applied by the Regional Administrator who issued the notice of ineligibility.

On March 1, 1984, an order was issued directing VCAPA to show cause why this case should not be dismissed for lack of jurisdiction. It is well settled that administrative law judges lack authority to rule on the validity of the regulations which they apply. Public Utilities Commission of California v. U.S., 355 U.S. 534 (1958); 20 CFR §658.425(a)(4))

Counsel for VCAPA responded by letter of March 8, 1984, stating that he knew of no grounds why the case should not be dismissed.

Accordingly, the appeal of VCAPA will be, and hereby is, dismissed.
