ORDER OF DISMISSAL

This matter was transferred to the Office of Administrative Law Judges in an Order of Reference dated November 1, 2004. On November 26, 2004, a Motion to Dismiss, arguing this matter as moot, was filed by the International Brotherhood of Teamsters, Local 236, and the International Union of North America, AFL-CIO, Local 386. On December 3, 2004, the International Union of Operating Engineers filed a Motion to Dismiss, adopting the arguments of the November 26, 2004 motion. On December 21, 2004, the undersigned issued an Order Granting Motion for Extension of Time and Order to Show Cause. This order requested a response by Management Logistics, Inc. and the U.S. Department of Agriculture, Forest Service to respond as to why this matter should not be dismissed as moot. These parties were given until January 5, 2005 to respond.

On January 5, 2005, the Department of Labor submitted the Administrator's Response to Order to Show Cause. The Administrator confirmed that the wage rates and fringe benefits that were paid under the predecessor contract will expire on January 31, 2005, and the collective bargaining rates that are being challenged in this matter will no longer apply after that date. Also, the Administrator stated that there is insufficient time for the undersigned to make a substantial variance determination before the matter becomes moot. As a result, the Administrator did not object to the dismissal of this matter. Responses were not received from Management Logistics, Inc. or the National Park Service by January 4, 2005.

Therefore,

IT IS ORDERED that this matter is dismissed as moot.
