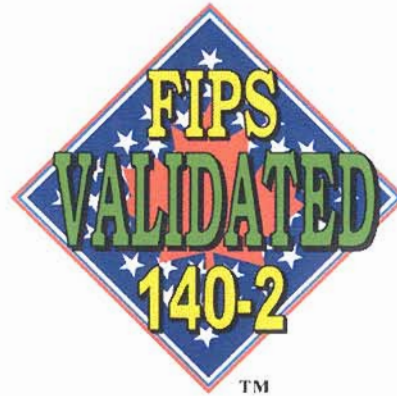

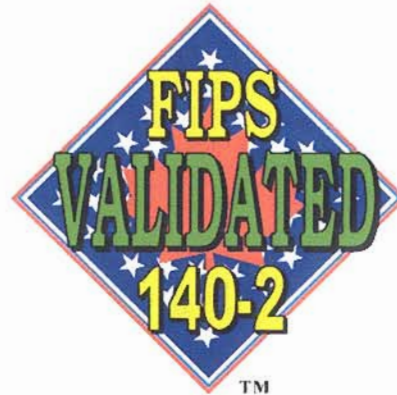

FIPS 140-2 provides four increasing, qualitative levels of security: Level 1, Level 2, Level 3, and Level 4. These levels are intended to cover the wide range and potential applications and environments in which cryptographic modules may be employed. The security requirements cover eleven areas related to the secure design and implementation of a cryptographic module. The scope of conformance achieved by the cryptographic modules as tested in the product identified as:

The following FIPS approved Cryptographic Algorithms are used: **DES (transitional phase only - valid until May 19, 2007; Cert. #311); Triple-DES (Cert. #333); AES (Cert. #88); SHS (Cert. #325); HMAC (Cert. #56); RSA (Cert. #63); RNG (Cert. #30)**

The cryptographic module also contains the following non-FIPS approved algorithms: **CAST 40 bit; CAST 128 bit; MD5; HMAC-MD5; Diffie-Hellman (key agreement, key establishment methodology provides between 70 and 97 bits of encryption strength); RSA (PKCS #1, key wrapping, key establishment methodology provides between 80 and 150 bits of encryption strength)**
