
**OBJECTIONS BY MOSAID TECHNOLOGIES INC.  
TO RAMBUS INC.'S SUBPOENAS OF BETTY PRINCE**

MOSAID hereby objects to the Subpoena Ad Testificandum and Subpoena Duces Tecum that Rambus served on Ms. Prince in this matter.

Rambus previously served a subpoena duces tecum on MOSAID in this matter. After MOSAID objected and moved to quash, Rambus withdrew its subpoena and MOSAID's motion was denied as moot. Rambus did not attempt to seek any further discovery directly from MOSAID. Because Ms. Prince possesses documents that relate to MOSAID, the Subpoena Duces Tecum of Ms. Prince effectively now seeks some of the documents that Rambus chose not to seek when it withdrew its subpoena on MOSAID. Similarly, the Subpoena Ad Testificandum now seeks testimony about matters potentially referenced in those documents. MOSAID therefore objects to Rambus' subpoenas of Ms. Prince to the extent they relate to MOSAID or the subjects of the withdrawn subpoena of MOSAID.
