Dear Mr. Zito:

We are writing in response to your letter of August 9, 2002 regarding Hynix's production of documents to the Commission.

Pursuant to your request, we notified the third parties whose documents had been included in the Hynix production regarding the FTC's production to Rambus. (You should have received copies of these letters.) We advised the third parties to contact you directly to address the level of confidentiality issue raised in your letter. We further advised them that such contact must be made no later than August 28, 2002. As these third party documents have now been provided to Rambus at least four times (each of the U.S. District Court cases and now the FTC proceeding), we would anticipate that all issues relating to confidentiality have been resolved.

As for the documents in the Hynix production that originated with Hynix, the designation of *Confidential Discovery Material*, as provided in the FTC Protective Order, is acceptable.
