EIGHTH JOINT STATUS REPORT

The parties hereby file their eighth joint status report relating to the status of Mr.

Chhabra's sentencing date in his criminal matter and of settlement negotiations in this case.

Complaint Counsel's Statement

On July 25, 2005 the judge in Mr. Chhabra's criminal proceeding held a status conference. Complaint Counsel had understood (and had advised this Court) that Mr. Chhabra's sentencing would take place at this conference, but it did not. Instead, the judge scheduled a sentencing date of Friday, August 5, 2005. Complaint Counsel will advise the Court of the results of the sentencing hearing as soon as the information is available.

There has been no progress in the settlement negotiations since the filing of the last status report. However, by email dated July 25, 2005, Counsel for Respondents stated that he will be available on Friday, August 29, 2005 to discuss settlement. Complaint Counsel looks forward to

this opportunity to discuss the revised settlement order that we forwarded to Counsel for Respondents on May 17, 2005.

Statement of Counsel for Respondents

Mr. Chhabra has been moved from the Alexandria, Virginia area to a location in western Virginia. Respondents' Counsel has not heard from Mr. Chhabra or consulted with him concerning this matter since he was incarcerated prior to sentencing.

On Friday, July 29, 2005, Respondents' Counsel will be in Washington, D.C. on other matters and notified Complaint Counsel that he would be available to further discuss some of the issues that have made a resolution of this case difficult. Respondents' Counsel looks forward to this meeting.

Conclusion

The next status report in this matter is due on or before August 17, 2005.
