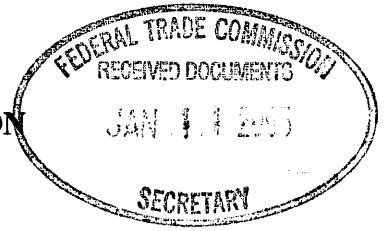

MOTION FOR LEAVE TO FILE
RESPONDENTS' SECOND AMENDED ANSWER


Pursuant to the Federal Trade Commission's Rules of Practice ("FTC Rules"), 16 C.F.R. §§ 3.15 and 3.22, counsel for Respondents, Evanston Northwestern Healthcare Corporation ("ENH") and ENH Medical Group, Inc. ("ENHMG") (collectively "Respondents"), move for leave to file the enclosed Respondents' Second Amended Answer.

Respondents filed their First Amended Answer on July 12, 2004, which differed from its original answer only insofar as it included answers to paragraphs 28-30 and 32 of the Complaint. These paragraphs related solely to Count II of the Complaint to which Respondents did not have to respond at the time they filed their original answer because of a pending motion to dismiss Count II, pursuant to FTC Rule § 3.12.

In order to streamline the case for trial, Respondents seek leave to file the attached Second Amended Answer, which only differs from the First Amended Answer in that it asserts fewer Grounds of Defense and admits to certain jurisdictional facts.

WHEREFORE, for these and such other reasons as may appear just to the Court, the parties request that this Motion for Leave to File Respondents' Second Amended Answer be granted, and that the attached Order be entered.
