**CONSENT MOTION TO REMOVE
ENH MEDICAL GROUP, INC. FROM CAPTION**

ENH Medical Group, Inc. (“ENH Medical Group”), by counsel, moves the Commission to remove ENH Medical Group from the caption of this case. Complaint Counsel has reviewed this motion and consents to the requested relief.

ENH Medical Group, which is a subsidiary of Respondent Evanston Northwestern Healthcare (“ENH”), was named as a respondent in the Complaint issued on February 10, 2004. The allegations in Count III of the Complaint against ENH Medical Group were resolved by a consent order that the Commission approved as final on May 17, 2005. After the settlement, the parties no longer considered ENH Medical Group as a separate respondent in this action. Accordingly, the Initial Decision of the Administrative Law Judge (“ALJ”) lists ENH as the only respondent in the caption, and the ALJ’s Order does not authorize any specific relief against ENH Medical Group.

For these reasons, ENH Medical Group asks the Commission to remove its name from the caption of this case. If this motion is granted, ENH Medical Group should be deemed to have withdrawn the notice of appeal it filed on November 2, 2005.


