In exercise of its legal and statutory attributions, in special the conferred ones by Decrees 2141 of 1992, 1840 of 1994, 1454 of 2001, and Agreement 00008 of 2001 and

CONSIDERING

That he corresponds to the ICA to certify the sanitary quality of the animal exports and its products when is required.

That the ornamentales fish coming from natural means to export are gathered together previously to their boarding in storage warehouses.

That the extracted ornamentales fish of natural means to export are isolated and they are not in contact with the enemy with other fish or wild fauna,

That to the ornamentales fish coming from natural means that have been gathered together previously in warehouses of storage to the export, sanitary inspection is made to them in the warehouses of storage, previous the expedition of the Zoosanitarios Certificates for export with not more than three days of anteriority to the boarding.

That the destiny countries do not demand the Certificate of Inspection Toilet like requirement to make their imports.

That it is not required to make the sanitary inspection in the exit place, inasmuch as the revision is made previously in the storage warehouses, being avoided therefore the duplicity of proceedings.

By which it is excepted of the documentary revision, the physical inspection and the expedition of the Certificate of inspection toilet-CIS in the site from exit to the exports of ornamentales coming from natural means and gathered together fish in storage warehouses

IT SOLVES:

I ARTICULATE 1.- To except of the documentary revision, the physical inspection and the expedition of the Certificate of Inspection Toilet, in the sites of exit of the country, to the exports of ornamentales fish coming from natural means, that have been maintained in storing in the storage warehouses, unless abnormal conditions appear.

ARTICLE 2.- The sanitary inspection to ornamentales fish coming from natural means, that have been maintained in storing in the storage warehouses, to export, will make the ICA of previous way in the storage warehouses, not more than three days before the boarding to the outside.

I ARTICULATE 3.- The present resolution modifies in pertinent article 9 of Resolution 003336 of the 28 of December of 2004, it will enter use as of the date of the publication in the Official Newspaper of Colombia and will have to communicate within the 10 following working days to the Andean Community and the World-wide Organization of Comercio OMC.
