## **NOTIFICATION**

- **5. Title, language and number of pages of the notified document:** Amendment of the Fisheries Resources Conservation Act (available in English, 2 pages).

## **6.** Description of content:

- 1. An international aquatic animal health certificate, issued by the competent authority of the exporting country, is required for the importation of aquatic animals which are listed in the Ministerial Ordinance. The diseases from which the competent authority of the exporting country must verify that imported aquatic animals is free include non OIE-listed diseases (ex. Koi Herpes Virus Disease).
- 2. The Ministry of Agriculture, Forestry and Fisheries may order an importer to detain the imported aquatic animals if the certificate attached to the aquatic animals does not verify that they are free from diseases listed in the Ministerial Ordinance.
- 3. A person who is ordered to detain the aquatic animals shall have the aquatic animals examined for a diagnosis when the person finds or suspects that the aquatic animals are infected with diseases listed in the Ministerial Ordinance. If the aquatic animals are proved to be infected with the diseases, the Minister of Agriculture, Forestry and Fisheries may order the person to burn, bury or disinfect the aquatic animals.
