The Fisheries Resources Conservation Act will be amended as follows:

If the Minister of Agriculture, Forestry and Fisheries considers that the aquatic animals may contain one or any Ministerial Ordinance-listed diseases, due to situations in the exporting country or any other reasons, the Minister may order the person who applies for the permission prescribed in section 1 of Article 13-2 to detain the imported aquatic animals in the
	way and for the duration which the Ministerial Ordinance prescribes.  2. A person who is ordered to detain the aquatic animals shall have the aquatic animals examined for a diagnosis according to the Ministerial Ordinance, when the person finds or suspects that the aquatic animals are infected with Ministerial Ordinance-listed diseases.
	3. A person whose aquatic animals are examined under section 2 of this Article shall detain the aquatic animals in the way which the Ministerial Ordinance prescribes until the person receives the result of the examination.
Article 13-4	If the imported aquatic animals are proved to be infected with Ministerial Ordinance-listed diseases, the Minister of Agriculture, Forestry and Fisheries may order the owner or the person in charge of the aquatic animals and/or their packages to burn, bury or disinfect the aquatic animals, the packages, and/or any other items which are suspicious of being infected with Ministerial Ordinance-listed diseases.
