Article 1-2
Ministerial Ordinance-listed diseases and aquatic animals as susceptible hosts to the diseases prescribed in Section 1 of Article 13-2 of the amended Fisheries Resources Act are as follows.

Article 1-5

The duration prescribed in Section 1 of Article 13-3 of the Fisheries Resources Conservation Act is as follows:

Article 1-6

The way prescribed in Section 1 of Article 13-3 of the Fisheries Resources Conservation Act is as follows:

- to maintain the imported aquatic animals isolated from other aquatic animals
- to disinfect water or any other liquid which was in a container or facilities of the imported aquatic animals when it is drained
- to disinfect a container or facilities of the imported aquatic animals when the aquatic animals are moved into another container or facilities
- · to burn or bury a container of the imported aquatic animals when it is dumped
- · to burn, bury or dispose carcass of the imported aquatic animals appropriately

Article 1-7

A person who has the aquatic animals examined under Section 2 of Article 13-3 of the Fisheries Resources Conservation Act shall report the following information in written or oral form beforehand.

- · name and address of the owner of the aquatic animals and the person in charge of them
- · name of the disease
- · species of the aquatic animals
- · location of the aquatic animals
- date when the person finds that the aquatic animals are suspected of infection, and condition of the aquatic animals
- · other useful information
