Description of content: As there were reports in Japan of herpes virus infection in early October 2003 and widely spread over the areas since the middle of the month inflicting a huge loss of cultured carp farms where this highly contagious disease could possibly be transmitted to other close countries and the outbreak control in the areas is not well-established, the Department of Fisheries (DOF) is authorized to temporarily suspend the issuance of such import permits of carp fish from Japan effective from the notified date in order to prevent the disease entering the country.
	Import permits issued prior to this effective date will still be valid subject to 15 days quarantine of the imported fish and a sampling test by the DOF for koi herpes virus.

8.	Nature of the urgent problem(s) and reason for urgent action: This emergency measure is to protect the local fish industry from the harm caused by the disease virus which is highly contagious and the outbreak control in the areas is not effectively established. The koi herpes virus has been included in the disease monitoring programme in ornamental fish exporting farms since August 2002. There is still no report of the koi herpes virus in Thailand.
