## **Property Transformation: 814 Snow Street**

This house at 814 Snow Street in Chattanooga has undergone some major changes! Formerly condemned, it has been transformed into a fully remodeled home.

The house was condemned in May 2005. At the time, the yard was unkempt, the foundation was deteriorating, the windows and doors were not secured to City Code, and the structure was vacant and unsecured.

When a property is in

violation of City Code, the owner has 30 days to correct all violations and bring the structure into compliance. If the property owner does not correct the violations within 30 days, the case is brought to City Court, where fines and court costs

can be assessed. In the case of this property, the owner was a financial institution, who fully rehabilitated the structure and placed it on the market. It is now a newly renovated house, fully compliant with City Code, and ready for new owners!

### Shallowford Road Exit Beautification Project

On Tuesday, January 31, Mayor Ron Littlefield, several community leaders and business owners broke ground on the first phase of the Shallowford Road exit beautification project.

Less than a month ago, this \$80,000 project was little more than an idea. But persistent public and private East Brainerd leaders met with the Mayor to discuss improving the off ramps to exit 5 on I-75 to make it more friendly and inviting. What resulted was a fast moving plan with generous contributors jumping on board.

130 Crepe Myrtles scattered in a triangle pattern with 650 Grey Owl Junipers planted within the triangle as ground cover."

Forester, is working with David Garner to remove all existing trees and shrubs and as Gene put it, "to clear the canvas for David Garner to create a beautiful work of art".

The Friends of East Brainerd is a 501(c)(3)organization established to implement smart growth in East Brainerd who first had the idea for the beautification project. It is their hope that drivers will slow down, exit, shop and stay at the hotels. The non-profit has enlisted both public and private parties including TDOT.
