## 1065 Stakeholders

We are also adding a link to the Tax Year (TY) 2006 **Form 7004** XML schemas and Business Rules that are posted on the 1120/1120S website. These schemas and business rules contain changes since the June 16 and June 28, 2006 posting, respectively.
